<u>Westwood Tennis Center.</u> There has been considerable progress at the Westwood Tennis Center. The Tennis Court lighting has been installed, surfacing of the courts are underway; some of the shade structures have been completed between the various courts. Windscreens and nets will be installed later this month. An indoor tennis facility will also move forward as soon as approval is received from the Federal Aviation Administration.

CITY MANAGER'S REPORT, continued:

East Library Branch. Bids will be opened on Thursday, February 16th for the East Library Branch and hopefully this will come forward for Council approval at the next City Council meeting on February 28th. A completion date is anticipated for mid-2018.

Sales Tax. The general purpose sales tax remittance for the month of February (reflecting sales during December) was \$4,885,412. This is a decrease of -\$93,037 (1.87%) from February, 2016 levels. Sales tax receipts are now 4.28% below last year's levels.

Amazon.Com will begin to collect sales tax from the Oklahoma customers beginning in May, 2017, and that impact will not be seen until July, 2017.

Oklahoma Economic Outlook. City Staff members had an opportunity to attend a presentation made by Dr. Russell Evans with the Economic Research and Policy Institute at Oklahoma City University. Dr. Evans said the local economy is an inflection point that will coincide with the changing fiscal year. Both energy industry and improving U.S. economy should be net positives for the state. Both state and metro economy will feel healthy by year-end. Sales tax may turn around in May of this year. FY 2017 reminiscent of mild recession while FY 2018 is set up for recovery.

Railroad Quiet Zone. The Railroad Quiet Zone Project is being implemented with final warning signs being installed this week. Notification from the Burlington Northern Santa Fe (BNSF) Railroad that the Quiet Zone will begin at midnight Friday with a 24 to 48 hour gradual decrease in the train horns. The Quiet Zone does not guarantee that the horn will never be sounded because train crews will have the discretion during different types of emergencies or safety issues. In addition, BNSF has federal requirements that horns must be sounded when there is maintenance being performed on the tracks. During a 24 hour period, horns are sounded a total of 2.5 hours a day and this will be a major change which will impact those who live near the railroad tracks.
