BACKGROUND: On 24 September 2013, City Council approved Contract No. K-1314-60 with Merritt Tennis Court and Track Systems for the Westwood Tennis Court Resurfacing Project. This project included cleaning, repairing surface cracks and low spots and resurfacing and re-striping all twelve tennis courts at the facility. The low guote received from Merritt was in the amount of \$38,880.

<u>DISCUSSION</u>: During October 2013, progress was made towards completing the Westwood Tennis Court Resurfacing Project and a partial payment was made. On 22 November 2013, the project was inspected by Parks and Recreation staff and found to be complete per specifications and a second partial payment was made.

RECOMMENDATION: It is recommended that City Council accept the Westwood Tennis Court Resurfacing Project as complete and authorize final payment in the amount of \$1,944 to Merritt Tennis Court and Track Systems. Funding is available in Maintenance of Existing Facilities, Westwood Tennis Court Resurfacing (account 050-9677-419.61-01; project EF0174).
