FIRST AMENDMENT TO LEASE AGREEMENT

1. Additional Antennas. In addition to the other antennas permitted in the Agreement, Lessor consents to the installation and operation of additional antennas, associated cables and equipment as more completely described on attached Exhibit 1-A. Lessor's execution of this Amendment will signify Lessor's approval of Exhibit 1-A. Exhibit 1-A hereby adds a page 3 to Exhibit A to the Agreement.

- 2. Rent. Commencing on the first day of the month following the execution of this Amendment, Rent shall be increased to Two Thousand One Hundred and Thirty One and 16/100 Dollars (\$2,131.16) per month, subject to further adjustments provided herein. On each anniversary of the Commencement Date, the monthly Rent will increase by Four Percent (4%) over the Rent paid during the previous year. Upon Lessee's removal of additional antennas,

Either party may record this memorandum at any time, in its absolute discretion.
- 6. Other Terms and Conditions Remain. In the event of any inconsistencies between the Agreement and this First Amendment, the terms of this First Amendment shall control. Except as expressly set forth in this First Amendment, the Agreement otherwise is unmodified and remains in full force and effect. Each reference in the Agreement to itself shall be deemed also to refer to this First Amendment.
- 7. Capitalized Terms. All capitalized terms used but not defined herein shall have the same meanings as defined in the Agreement.

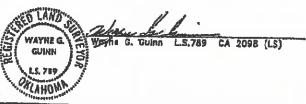

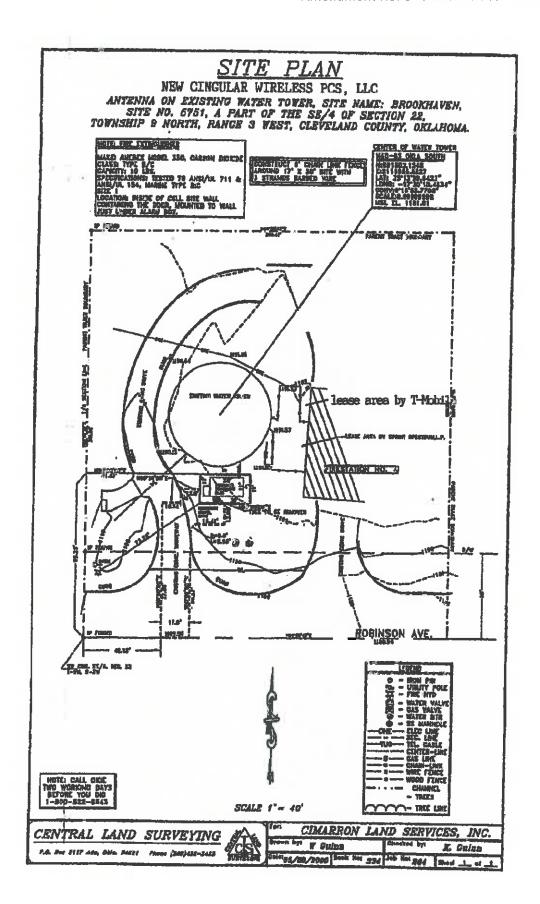
