## FINANCE COMMITTEE MINUTES March 20, 2013

# <u>DISCUSSION REGARDING THE FOLLOWING OUTSIDE AGENCIES FUNDING REQUESTS FOR FYE 14</u>

<u>CART</u> – increase in handicap hours, general operational increases. For FYE 14, CART is asking for an increase of \$50,000 making their total \$500,000. Mayor wants CART to come and explain request in more detail (after preliminary budget).

<u>Performing Arts Studio</u> – current budget is \$3,000 and Committee is recommending keeping it the same. Funds are for hosting and coffee supplies – approximately 5% more ridership than last year.

89er Day Parade - \$3,500 for food and County Fair Board – using County property/fairgrounds for event. They are requesting \$5,000 for FYE 14.

Norman Economic Development Coalition – no discussion.

<u>Aging Services</u> – Need a budget increase for FYE 13. Their budget is \$7,500 and would like an increase of \$4,500 for a total of \$12,000. They have \$700 balance and would need an additional \$3,800. For FYE 14 they are asking for an additional \$1,000 for a total of \$13,000.

Castleberry – if an agency did not make presentation, budget for FYE 14 should remain the same.

Finance Committee recommends the following action to full council for FYE 14.

- No to increase for Historical House for FYE 14. The Society needs to go to Cleveland County Commissioners and ask for assistance.
- Approve increase for CCFI for a total of \$10,000.
- Approve increase for Kiwanis Kruiser for a total of \$13,000.
- Deny increase for Historical Society.
- Budget CART and NEDC at same level for FYE 14 as they received in FYE 13.

## POTENTIAL GREEN FEE INCREASE FOR WESTWOOD GOLF COURSE

Jud Foster made presentation.

- First phase of green fee increase began April 1, 2012 \$1.5 per round, fee increased from \$21.50 to \$23 per round.
- Would like to begin phase 2 on April 1, 2013 with an increase of \$1.50 per round, total will be \$24.50 per round.
- No reduction in rounds played or complaints about fee increases.
- Projected increase of \$21,500 to FYE 13 revenues, \$59,500 increase to FYE 14 revenues with the green fee increases.
- Approximately \$70,000 ahead of this time last year.
- Committee recommends increase in green fee as long as Norman's fee is not more than Oklahoma City courses.

#### MID-YEAR BUDGET APPROPRIATION TO RAINY DAY FUND FROM GENERAL FUND

- Approximately \$572,000 short, the Committee still wants to wait until May to consider a recommendation related to the deposit.
- Mayor wants to make deposit this fiscal year, but wants full Committee participation.
- Castleberry can we afford to put in Rainy Day Fund this year? Wants to wait a couple more months.
