MISCELLANEOUS DISCUSSION

Corona Virus (COVID-19). Councilmember Holman said he had received many messages from friends wanting more information about what is going on in Norman regarding COVID-19. He said his job is considered essential so he is working Monday through Friday from 8 a.m. to 5 p.m. He said he is trying to work on plans to make his customers safe, but it is all new for everybody. He encouraged the residents of Ward 7 to tune in to City's YouTube channel for frequent updates.

Councilmember Scanlon said he had recently given blood and received a t-shirt for his efforts. He urged everyone to give blood during this time because there is definitely a need.

Councilmember Wilson said this is a difficult time for everybody and she appreciates the extreme efforts the City of Norman has gone to ensure that Council can continue governing the city. She said the virus has deeply affected her business and she said a lot of our small businesses are not going to make it. She encouraged everyone to go onto the Small Business Association (SBA) website to apply for disaster funding. She said she had been called by a caseworker today from SBA and they are making steps to take care of people.

Councilmember Wilson encouraged people to walk outside and stay six feet from anyone else and to stay sanitized.

Miscellaneous Discussion, continued:

Corona Virus (COVID-19) continued. Councilmember Hall thanked City Staff for all they are doing and putting themselves in harm's way on a daily basis to run the City. She said staff was running a virtual meeting to keep people safe. She thanked Mayor Clark for her continued bold leadership during this time. She said Norman has been a leader in the state of Oklahoma by taking the threat of COVID-19 seriously. She said she hopes everyone stays safe and stays home. She urged people to become familiar with their neighbors and neighborhoods and to help out when their neighbors have needs. She encouraged Ward 4 business owners to stay in touch with her. She asked people to watch YouTube and read Norman News.

Councilmember Petrone said that everyone needs to practice patience. She said she is not used to so much togetherness in her home but they will get through it.

Councilmember Petrone thanked *the Norman Transcript* for allowing people access to read information about COVID-19 free of charge.

Councilmember Carter said he is bewildered that there is not enough testing for COVID-19. He said someone came to his veterinary clinic last week wondering if he had Virus Isolation Swabs and his staff gave them six. He said testing is just a standard procedure and blanket quarantines are not needed. He said this should really be done on a case to case basis. He said there has to be a better way to manage the situation.

Councilmember Bierman said she with Councilmember Wilson closed three out of four locations and laid off 20 people. She said this was done so they could file for unemployment immediately. She said she knows that is what everyone else is going through. She said the disability community, the independent living facilities and the nursing homes are the ones struggling the most and she is part of a group that provides assistance. She urged people to send a note to their neighbors to get to know each other in order to help each other.

Mayor Clark thanked Council for their support. She said everyone is adapting and doing the best they can.
