BACKGROUND: The Wal-Mart Foundation announced that Facility Giving funds are available to the City of Norman for use in the Norman Police Department in the amount of \$1,000.

DISCUSSION: It is the intention of the Norman Police Department to use these funds to conduct an eight-hour police recruiting seminar designed to encourage women to consider a career in law enforcement with the Norman Police Department. We anticipate an attendance of approximately fifty women. The funds will be used for the following: Program, keynote speaker, travel and per diem expenses - \$450; Refreshments for participants - \$300; Facility rental - \$250.
