That in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, that Bobby D. Tims, does hereby grant, bargain, sell and convey unto the **City Of Norman**, a municipal corporation, a **public roadway, drainage and utility easement**, over, across and under the following described real estate and premises situated in Cleveland County, Oklahoma, to wit:

**(17' Additional R/W)**

A tract of land in Government Lot Four (4) of the Southwest Quarter (SW1/4) of Section Thirty (30), Township Nine (9) North, Range One (1) West of the Indian Meridian, Cleveland County, Oklahoma, written by Timothy G. Pollard, PLS 1474 dated September 17, 2019 using a Deed bearing of N00°01'29"W between existing monuments on the West line of said SW1/4 as a Basis of Bearing, said tract further described as:

**COMMENCING** at the Southwest Corner of said SW1/4;  
Thence N00°01'29"W, on the West line of said SW1/4, for a distance of 449.80 feet;  
Thence S89°58'16"E for a distance of 33.00 feet to the **POINT OF BEGINNING**;
