# Item 3. Update on complaint filed by William Hickman on March 24, 2014.

Chairman Hardiman said Mr. William Hickman filed a complaint against Councilmember Greg Jungman on March 24, 2014, and the Norman Election Committee (NEC) requested an opinion from the Legal Department. Mr. Jeff Bryant, City Attorney, said the Legal Department reviewed the complaint, but does not have a conclusion for the NEC at this time. He said as far as the charge of the NEC, this complaint will probably fall under the Ethics Policy as to whether or not Councilmember Jungman acted ethically by using his City e-mail for transmitting campaign messages. He visited with Councilmember Jungman regarding that and Councilmember Jungman assured Mr. Bryant he did not use the City e-mail for any type of transmission of campaign messages and the Legal Department is reviewing the complaint. He said his review of the complaint, so far, has been that no violation has occurred and any review under the Ethics Policy would not be something the NEC would discuss.

Chairman Hardiman said as Committee Chair he responds to any written complaints submitted to the NEC with a written response and he will do so when the Legal Department has finished their review.

Mr. Bill Hickman, Hickman for Ward 4, said he requested copies of emails on March 14th and asked the timeframe of obtaining those emails and Mr. Bryant said the emails were collected from the City server onto a disc and Councilmember Jungman asked to be allowed to review them to make sure there are no personal information that would be exempted.

Ms. Hampton stated emphatically that City emails are open records and nothing personal is supposed to be in City emails and to withhold those emails for the length of time that has passed since the record request was made seems to be an egregious violation of the Open Records Act (ORA). She asked how the City could legally justify withholding the emails for Councilmember Jungman to review prior to releasing them to Mr. Hickman. Chairman Hardiman said he understands the question regarding the timeline, but this subject is not under the NEC's purview and Ms. Hampton could meet with Mr. Bryant after the meeting.

Chairman Hardiman said the NEC will provide a written response to Mr. Hickman regarding the results of the investigation into the alleged violation of Section 7.5 and the Ethic's Policy. NEC will notify Mr. Hickman that since there was no financial impact to the emails, there would be no need to report them in the contribution and expenditure reports. The letter will also inform Mr. Hickman that the complaint regarding a violation to the Ethics Policy does not fall under NEC's purview and the City Attorney's Office has investigated and will be respond to that complaint.
