A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, AUTHORIZING COMPROMISE SETTLEMENT OF TWO CLAIMS FILED BY STEVEN DALE DUREN UNDER THE PROVISIONS OF THE WORKERS' COMPENSATION STATUTES OF THE STATE OF OKLAHOMA IN THE TWO CASES OF STEVEN CITY OFWORKERS' NORMAN, DURENV. THECOMPENSATION CASE NOS. WCC 2011-13882 Y, AND WCC 2011-13883 A; DIRECTING THE LEGAL DEPARTMENT TO THEN FILE SUCH SETTLEMENT AND ALL ATTENDANT COSTS IN THE **OKLAHOMA** COMPENSATION COURT, WORKERS' AND DIRECTING THE **AUTHORIZING** AND OKLAHOMA; FINANCE DIRECTOR TO SUBSEQUENTLY PURCHASE SUCH WORKERS' COMPENSATION COURT JUDGMENTS FROM THE RISK MANAGEMENT INSURANCE FUND.

- §1. WHEREAS, STEVEN D. DUREN was a Fire Driver Engineer for the Fire Department who alleged a single incident injury on December 28, 2011, and cumulative injuries with a date of last exposure on June 25, 2011; and
- §2. WHEREAS, the City of Norman has negotiated settlement for the claim of STEVEN D. DUREN against the City of Norman, Case No. WCC 2011-13882 Y (hearing loss) under the Workers' Compensation Statutes for \$4,263.60, to be paid in a lump sum settlement to Mr. Duren and his attorney, and such settlement is believed to be fair and reasonable; and
- §3. WHEREAS, the City shall incur additional costs for the settlement of WCC 2011-13882 Y for payment to the Workers' Compensation Administration Fund in the amount of \$85.27; the Special Occupational Health and Safety Fund in the amount of \$31.98; for filing fees in the Workers' Compensation Court in the amount of \$140.00; and filing fees in the Cleveland County District Court in the amount of \$125.70; and
- §4. WHEREAS, the City of Norman has negotiated settlement for the claim of STEVEN D. DUREN against the City of Norman, Case No. WCC 2011-13883 A (back) under the Workers' Compensation Statutes for a \$12,920 to be paid in a lump sum to Mr. Duren and his attorney, and such settlement is believed to be fair and reasonable; and
- §5. WHEREAS, the City shall incur additional costs for the settlement of WCC 2011-13883 A for payment to the Workers' Compensation Administration Fund in the amount of \$258.40; the Special Occupational Health and Safety Fund in the amount of \$96.90; for filing fees in the Workers' Compensation Court in the amount of



- \$140.00; and filing fees in the Cleveland County District Court in the amount of \$125.70; and
- §6. WHEREAS, the Risk Management Insurance Fund of the City of Norman has heretofore appropriated funds for the payment of Workers' Compensation settlements covering injuries to qualified persons employed by the City of Norman; and
- §7. WHEREAS, the judgment and award should be transmitted and certified to the Workers' Compensation Court, Oklahoma City, Oklahoma, which when filed will constitute judgment against the City of Norman, which it is entitled to purchase with funds out of the Risk Management Insurance Fund pursuant to Okla. Stat. tit. 85, § 301, Okla. Stat. tit. 51, § 159, and Okla. Stat. tit. 62, § 361, et seq.; and
- §8. WHEREAS, the City Council finds it will be in the best interest of the City if the funds of the Risk Management Insurance Fund are invested in said judgment; and
- NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:
- §9. That the Legal Department is authorized to enter into settlement with one STEVEN D. DUREN for not more than \$17,183.60 for any and all claims that he has or may have against the City of Norman under the Workers' Compensation Statutes for any and all injuries known or unknown which occurred while working for the City of Norman; and
- §10. That the Legal Department is directed to hereinafter file such settlement in the Workers' Compensation Court, Oklahoma City, Oklahoma, along with all attendant costs therefore, as provided by law; and
- §11. That the Finance Director is authorized and directed to purchase such judgments of the Workers' Compensation Court, Oklahoma City, Oklahoma, out of funds of the Risk Management Insurance Fund of the City of Norman.
