## MISCELLANEOUS DISCUSSION

Traffic Safety. Mr. Bobby Stevens, Post Office Box 6226, said he is concerned about safety issues on State Highway 9 (SH9). He said the highway's dangerous reputation is well known in Norman as well as other communities. He said the highway's vehicle accident fatality rate is extremely high. He felt local or State representatives need to step up and take a stand on addressing safety issues and improvements need to be done now not later. He said the City of Norman and the Oklahoma Department of Transportation (ODOT) should be able to work together to construct turn lanes, install traffic lights, and install no passing signs. He said turn lanes are desperately needed for entry into housing additions along the highway. He said Noble Public Schools have school busses picking up students along Highway 9, which is very dangerous.

Councilmember Kovach said if there are problems in the City, the City needs to look for solutions. He said there is an ODOT project for portions of SH9 coming forward soon, but there are things people can do as a community. He suggested the City of Norman Police Department and Cleveland County Sheriff's Office coordinate increasing patrols on the highway. He said a lot of reported accidents seemed to be caused by speeding or following too closely and that is something that can be controlled. He said everyone seems to be in a distracted state at this time of year and urged everyone to be safe and mindful of others.

Councilmember Spaulding asked the timeline of the Highway 9 Project and Mr. Shawn O'Leary, Director of Public Works, said there is an \$18.5 million allocation from the State for two projects on Highway 9. He said work between 24th Avenue and 36th Avenue east will begin construction in June 2013, and City Staff is working with ODOT to move that project forward as quickly as possible. He said 36th Avenue to 72nd Avenue east is scheduled for construction approximately one year to eighteen months later. He said the projects will expand two lanes to four lanes with enhancements to intersections. He said City Staff shares the communities concerns and sorrow over any accident especially those involving fatalities. He said anytime an accident occurs, Staff looks for short term, mid-term, and long-term solutions through enforcement, education, and engineering. He said current solutions include better lighting at intersections, better signage, street signs, flashing lights, etc. He said there has been a reduction of accidents and an improvement in safety. He said there has been an exponential growth in distracted driving. He said a Town Hall meeting was held in 1999, and at that time citizens requested ODOT improve all of Highway 9 and address safety concerns. He said ODOT has planned improvements to 72nd Avenue, but there are no plans or funding to go further east. He hopes upcoming discussions with ODOT will include extending the vision.

Councilmember Spaulding asked if the projects include turn lanes at every intersection and Mr. O'Leary said yes. Councilmember Spaulding encouraged Councilmembers to contact State representatives and urge them to move forward with plans east of 72nd Avenue to 180th Avenue.

Councilmember Williams said he discussed traffic safety concerns in Ward 8 with Mr. O'Leary and he knows Staff is continually studying traffic issues and trying to find the best solutions for traffic safety. He said public input is taken into consideration in the process.

Mr. Steve Lewis, City Manager, said ODOT has safety experts that review and analyze traffic safety problems and the City is asking them to intervene and work with the Norman Police Department looking at trends and ways to approach the issues.

United Way. Mayor Rosenthal congratulated the United Way on exceeding their fund raising goal and congratulated the entire community for their support of the institution and the agencies that benefit from it.

\*

Staff Response: Mr. Evan Dunn, 1014 Missouri Street, thanked City Staff for their quick response to his e-mails this week. He e-mailed the Mayor regarding a community volunteer program for planting trees along Main Street and she promptly replied stating she would forward his suggestions to the Parks and Recreation Department. He e-mailed Mr. Ken Komiske, Director of Utilities, about the Request for Proposals (RFP) for the residential recycling contract and Mr. Komiske e-mailed him a copy of the RFP. He contacted Ms. Linda Price, Revitalization Manager, regarding code issues and she adequately addressed his question regarding code compliance on amenities of private property that become obstructions into public space. He was surprised to find out that the City does not have the authority to remediate code compliance issues without proper time and notice to the property owner.

Miscellaneous Discussion, continued:

Multi-Modal Transportation. Mr. Evan Dunn, 1014 Missouri Street, said he contacted Mr. Shawn O'Leary, Director of Public Works, regarding the idea of maximizing the right-of-way on certain streets in Norman to accommodate the "complete street idea" and multi-modal transportation. Mr. O'Leary provided him with the information he needed as well as a contact person at ODOT he could speak to about "complete highways" which goes beyond the scope of municipal government. He said more people are wanting to "bike" to work, to Lake Thunderbird, and other areas in the community and complete highway systems that allow this is important. He urged Councilmember Kovach to bring up discussion at the next Association of Central Oklahoma Governments (ACOG) meeting. He said another ACOG issue would be a metro area train transit system as a way for people in Moore, Edmond, and Norman to travel to and from jobs in Oklahoma City.

Councilmember Kovach said ACOG is in the middle of an 18 month regional transit dialogue and information is available on their website. He said the City of Norman is well represented in that dialogue.

Parkinson's Disease. Councilmember Castleberry said Dr. Nicole Jarvis, an Obstetrics and Gynecology (OB-GYN) physician in Norman and mother of twins, was recently diagnosed with Young Parkinson's Disease. She is holding a gala this weekend to raise money for research and he encouraged everyone to support her fund raising efforts.

Budget Transparency. Councilmember Castleberry said he spoke with the City Manager recently regarding better transparency of the City's budget. He said as part of that effort, City of Norman employee positions and salary ranges are now posted on the City's website.

\*

Community Planning and Transportation Meeting. Councilmember Jungman said the next Community Planning and Transportation Committee meeting will be held on Monday, December 17, 2012, at 5:30 p.m., for discussion on the High Density Development ordinance. He encouraged those that have interest to please come and participate in that discussion.

Councilmember Griffith said he really hoped for public participation at the meeting because a lot of effort was put forth by the public and City Staff in garnering input the Planning Department needs to put together an effective draft ordinance that will define how the community wishes high density development to occur. He invited everyone to attend the meeting as the Committee reviews the first draft of the proposed ordinance.

Animal Shelter. Councilmember Gallagher said the Animal Oversight Committee has met three times with the design architects for the new Animal Welfare Facility. He said the architectural firm is staying within the budget and making some very well organized plans that emphasizes the animals, not the people.

\*

Christmas Parade. Councilmember Gallagher said the Christmas Parade was really good this year.

Councilmember Williams thanked everyone who came to the Christmas Parade as it was the best turnout he has ever seen. He thanked Fire Chief Fullingim for the ride in the fire truck.

Mayor Rosenthal said she enjoyed riding in the fire truck basket during the Christmas Parade and thanked Fire Chief Fullingim. She expressed her appreciation to the organizations that pulled together during this holiday season in order to help those less fortunate.

Christmas Light Display. Councilmember Spaulding invited everyone to view the Christmas light display on 72nd Avenue, south of Highway 9.

Miscellaneous Discussion, continued:

Reason for the Season. Councilmember Spaulding said Christmas Day is a couple of weeks away, but unfortunately there is a lot of depression at this time of year because the commercialization of the holiday puts stress on people. He reminded everyone that the stress, finances, loneliness, and sadness from the loss of loved ones do not have to be a part of the Christmas season. He said the Department of Environmental Quality (DEQ) finished technical work on impairments in Lake Thunderbird and Total Maximum Daily Load (TMDL). He said TMDL is simply an acronym for the amount of pollution a water body can take without violating water quality standards. He said the TMDL Study is on DEQ's website and Staff is reviewing it now.

Annual Tree Lighting Ceremony. Mayor Rosenthal thanked the Parks and Recreation Department Staff for a great kick-off to the season at the annual tree lighting event in Andrews Park. She said turnout was great with a wonderful showcase of young people in our community.
