MISCELLANEOUS DISCUSSION

Norman Economic Development Advisory Board (NEDAB). Mr. Steve Ellis, 633 Reed Avenue, said much had been said during discussion of Item 41 about how well things would work but there had been no evidence that economic incentives would increase the aggregate economic activity in the community. He said it is very difficult to see where things go wrong when a company is recruited. He said extensive research had been done regarding incentives given to Warren Theatre to come to the City of Moore, but there had been no increase in the number of jobs. He said the best thing to do for economic development is to make a town a fantastic place to live, then companies will come whether you provide incentives or not, for example, Crest Market. He said now NEDA will get credit for when the next company decides to build in Norman and these companies can be persuaded to come without offering incentives. He felt the establishment of NEDA will cause companies to come looking for something even though we might not say yes to every company. He urged Council to be extremely careful about what companies are chosen because if a mistake is made, it will probably cost the City of Norman money and might not make Norman a better place to live.

Councilmember Lockett thanked everyone who attended the Business and Community Affairs meetings. She said there had been a tremendous amount of input and the result had been a reasonable ordinance and policy.

Miscellaneous Discussion, continued:

Items 38 and 39, Rose Rock School Rezoning Items. Mr. Sean Rieger, 136 Thompson Drive, said Council received a letter from the applicant withdrawing Items 38 and 39. He said a sentence in the letter said "they are withdrawing the current application while reserving their right to move forward with the current application at a later time." He asked for clarification that this was absolutely a withdrawal without conditions and without any right to revive it at some later time. Mayor Rosenthal said the applicant submitted a letter of withdrawal and Council accepted it and took no action. Mr. Rieger asked if this applied unconditionally to Items 38 and 39?

Mr. Jeff Bryant, City Attorney, said the letter only referenced one item, the Ordinance rezoning the property, but the second item was the plat which was tied to the rezoning item so when the applicant submitted the request for withdrawal, Staff assumed it was for both items and Staff took both items off of the agenda and it required no Council action. Medieval Fair. Councilmember Lockett thanked the Parks and Recreation Department who helped with the Medieval Fair. She said there had been a great turnout in spite of the weather.

Norman Economic Development Coalition (NEDC). Councilmember Lockett provided an explanation to a question raised at a prior Council meeting and said NEDC owns their building on Asp Avenue and the City of Norman does not. She said it is important to clarify facts.
