A strip of land lying in the Southwest Quarter of Section 36, Township 9 North, Range 3 West of the Indian Meridian, Cleveland County, Oklahoma being more particularly described as follows:

BEGINNING at the southeast corner of Lot 1, Block 1, VILLAGE WEST ADDITION, an Addition to the City of Norman, Cleveland Count, Oklahoma, according to the plat recorded in Book 8 of Plats, Page 78;

THENCE North 89°45'02" East, parallel with the south line of said Southwest Quarter, a distance of 150.00 feet;

THENCE South 00°14'59" East a distance of 17.00 feet;

THENCE South 89°45'02" West, parallel with the south line of said Southwest Quarter, a distance of 150.00 feet;

THENCE North 00°14'59" West a distance of 17.00 feet to the POINT OF BEGINNING.
