Maintenance Bond MB-1718-24, attached hereto, will be executed upon NUA approval of this Change Order No. 5 and will apply only to the Norman WRF Phase 2 Maintenance Improvements approved by the NUA as Change Order No. 4 on February 14, 2017. The two-year coverage period for Maintenance Bond MB-1718-24 will begin upon NUA acceptance of the Norman WRF Phase 2 Maintenance Improvements.
