Property Legal & Site Description: 3900 E Robinson St. - Lots 15,16 & Part of Lot 17, Re-plat of Pecan Heights Addition (A Part of the NW/4, Section 26, T9N-R2W, IM – Norman, Cleveland County, Oklahoma. Containing 14.45 acres.

100-year flood boundary is approximately 10.2 acres. The 2008 revised floodplain map shows a portion of the lot and house are in the floodplain according to FEMA.

Existing house is 3,977 sf - 5 bedroom, 4 full baths, 1 office and ample space for group meeting room. Parking – Ample parking in place for requested use. Existing drive is private, no other interior streets. Traffic generation is low for proposed in treatment facility.

Signing – Signing to follow the Office signage regulations for single business use.

Lighting – to be typical for rural residential area, directed inward and away from adjacent properties, all new fixtures will be full cut-off.

Open space areas will remain as currently shown.

Services and Business Use Description

The existing Living Hope EDTC office is located at 909 26th Ave. N.W., Norman, OK 73169. It operates Monday through Friday from 9:00 AM until 6:30 PM at the current location. The residential treatment program will be located at 3900 E. Robinson St., Norman, OK 73026. It will operate 24 hours per day, 7 days per week, and 365 days per year. New patients in the residential treatment program will undergo a two-hour initial assessment at our existing office. This includes a screening for drugs and alcohol prior to admission to residential treatment. Patients struggling with addiction as well as their eating disorder will be referred to an alternate location to address their addiction, and will not be admitted to Living Hope EDTC's residential eating disorder treatment program. Living Hope EDTC's residential treatment program provides meal support and dietitian and therapy groups.

A registered nurse and a tech will be present on site 24/7/365 with the patients. Additional staff will come and go as needed. There will be a maximum of 10 patients (1-2 patients maximum per room as per building

code requirement) at the facility at any given time; however, these patients will not have private vehicles at the facility. Patients will receive 24 hour per day, 7 day per week treatment while in residential level of care. Average length of stay at residential treatment is 60 days.

Background

Living Hope Eating Disorder Treatment Center has operated as a business since August 15th, 2011. The clinic was founded as a response to a lack of comprehensive medical treatment facility in the Oklahoma City area that specifically addresses patients with Anorexia Nervosa, Bulimia Nervosa, Binge Eating Disorder, Compulsive Overeating Disorder, Other Disorders of Eating, and Avoidant/Restrictive Food Intake Disorder.
