A tract of land shown adjacent to the Final Plat of Monterey II, an addition to the City of Norman, Oklahoma and located in the Southwest Quarter of the Northwest Quarter of Section 16, Township 8 North, Range 2 West, I.M., Cleveland County, Oklahoma being more particularly described by metes and bounds as follows:

COMMENCING at the Southwest corner of said Northwest Quarter,

Thence North 89°17'02" East along the South line of the Northwest Quarter of a distance of 1067.20 feet to the POINT OF BEGINNING;

Thence North 00°33'06" West, a distance of 173.48 feet;

Thence North 89°26'54" East, a distance of 206.00 feet;

Thence South 45°33'06" East, a distance of 14.14 feet;

Thence North 89°26'54" East, a distance of 145.06 feet;

Thence South 00°12'14" East, a distance of 162.45 feet;

Thence South 89°17'02" West along the South line of said Northwest Quarter, a distance of 360.08 feet to the POINT OF BEGINNING.

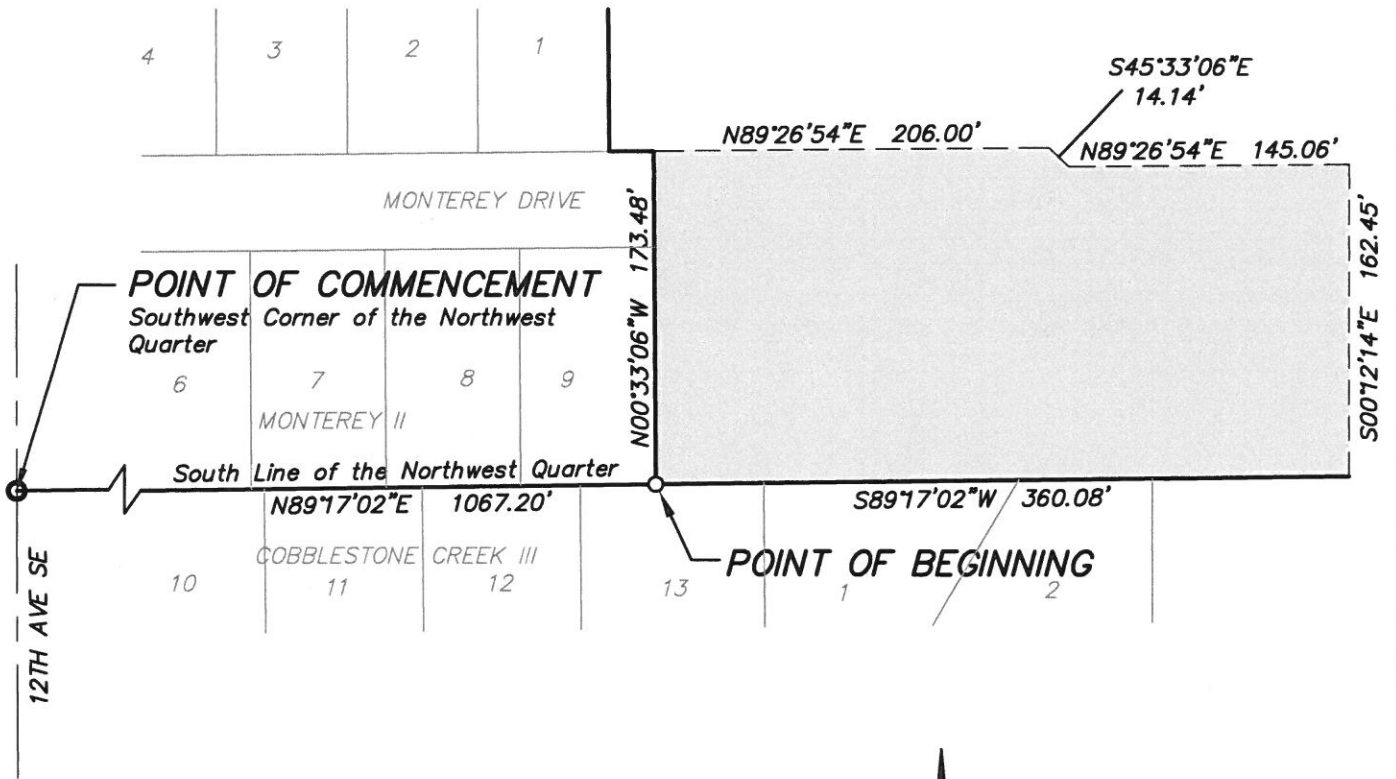
