A strip, piece or parcel of land lying in the Northwest Quarter (NW/4) of Section Fourteen (14), Township Nine (9) North, Range Three (3) West of the Indian Meridian, Cleveland County, Oklahoma. Commencing at the Southwest Corner of the Southwest Quarter (SW/4) of Section 14;

Thence North 90°00'00.00" East a distance of 60.00 feet to the point of Beginning;

Thence North 90°00'00.00" East a distance of 5.00 feet;

Thence South 00°27'55.57" East a distance of 36.24 feet;

Thence North 89°56′14.83" West a distance of 5.00 feet;

Thence North 00°27'55.57" West a distance of 36.23 feet to the Point of Beginning;

Said parcel containing 181.19 square feet, or 0.00 acres more or less, of a Temporary Driveway Easement for sidewalk improvements.
