A RESOLUTION OF THE CITY OF NORMAN, OKLAHOMA (THE "CITY") APPROVING THE INCURRENCE OF INDEBTEDNESS BY THE NORMAN MUNICIPAL AUTHORITY (THE "AUTHORITY") ISSUING ITS SALES TAX REVENUE NOTE, TAXABLE SERIES 2020 (THE "NOTE"); PROVIDING THAT THE ORGANIZATIONAL DOCUMENT CREATING THE AUTHORITY IS SUBJECT TO THE PROVISIONS OF THE NOTE INDENTURE: AUTHORIZING THE ISSUANCE OF SAID NOTE: WAIVING COMPETITIVE BIDDING WITH RESPECT TO THE SALE OF SAID NOTE AND APPROVING THE PROCEEDINGS OF THE AUTHORITY PERTAINING TO THE SALE OF SAID NOTE; RATIFYING AND CONFIRMING A SALES TAX AGREEMENT BY AND BETWEEN THE CITY AND THE AUTHORITY PERTAINING TO THE YEAR-TO-YEAR PLEDGE OF CERTAIN SALES TAX REVENUES, AND AND AUTHORIZING AN**AMENDED** SALES AGREEMENT; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:

<u>SECTION 1. INDEBTEDNESS AUTHORIZED.</u> The Norman Municipal Authority (the "Authority") is hereby authorized to incur an indebtedness by the issuance of its Sales Tax Revenue Note, Taxable Series 2020 in the amount of \$22,250,000.00 (the "Note"), all according to the terms and conditions of a Note Indenture dated as of December 1, 2015, as previously supplemented and amended, and as further supplemented and amended by a Series 2020 Supplemental Note Indenture, both by and between the Authority and BancFirst, as Trustee (the "Note Indenture"), provided that said Note shall never constitute a debt of The City of Norman, Oklahoma (the "City").

<u>SECTION 2. ORGANIZATIONAL DOCUMENT SUBJECT TO INDENTURE</u>. The organizational document creating the Authority, is hereby made subject to the terms of the Note Indenture authorizing the issuance and securing the payment of the Note as more fully described in Section 1 hereof.

<u>SECTION 3.</u> <u>WAIVING COMPETITIVE BIDDING; APPROVAL OF SALE PROCEEDINGS</u>. The waiving of competitive bidding for the sale of the Note and the sale of said Note by the Authority to _______, at a price of par, is hereby approved.

SECTION 4. SALES TAX AGREEMENT. The City hereby ratifies and confirms that certain Sales Tax Agreement dated as of December 1, 2015, between the City and the Authority (the "Sales Tax Agreement"), which Sales Tax Agreement pertains to a year-to-year pledge of certain sales tax revenue as security for the Note. Furthermore, the City hereby approves and authorizes execution of an Amended Sales Tax Agreement for the purpose of adding the year-to-year pledge of one-half of one percent (0.5%) use tax as additional collateral securing the Note and obligations issued on a parity therewith pursuant to the Indenture.

<u>SECTION 5</u>. <u>AUTHORIZING EXECUTION</u>. The Mayor or Vice Mayor and City Clerk or Deputy City Clerk of the City representing the City at the closing of the above-referenced note issue are hereby authorized to execute and deliver on behalf of the City any and all certifications and documentation necessary or attendant to the delivery of the Note, as directed by Bond Counsel.
