## MISCELLANEOUS DISCUSSION

<u>University North Park.</u> Ms. Jacy Crosbie, 204 Mountain Oaks Drive, said Designer Shoe Warehouse has a new store in University North Park and is advertising their location as being in the Norman Town Center. She said many could be confused by the development being called University North Park because they might think it is a park instead of a retail area. She said Norman Town Center is a better name and suggested the City consider changing the name of the development.

Election. Ms. Jacy Crosbie, 204 Mountain Oaks Drive, said she had received her absentee ballot for the special election on Tuesday, November 12th regarding the wastewater rate increase. She said the wording of the ballot does not give specific information about how the money would be used. She said there had been discussions about using the money for the existing south plant or for a new north plant and it should be specified in the ballot because the citizens would really appreciate knowing before they voted.

Mr. Steve Lewis, City Manager, said a public information meeting will be held Tuesday, October 29th at 6:30 p.m. in the Council Chambers. There will be a short presentation about the wastewater rate increase followed by a question and answer session. He said on the home page of the website is information regarding the purpose of the election and a public information flyer will be sent to all households in Norman later this month. He said there is a lot of information available to the voters about the election. He said revenue raised through this election will be used exclusively for improvements to the South Wastewater Treatment Plant.

Agenda Items: Ms. Ann Gallagher, 1522 East Boyd Street, thanked Mr. Shawn O'Leary, Director of Public Works, for explaining how the money would be spent on the Lindsey Street Project. She also thanked Councilmembers who ask for presentations so the public will be better informed. She thanked Councilmembers who study agenda items because it is important for citizens to know Council is taking the time to read each item. She thanked Councilmember Castleberry for bringing up the issue of discussing topics that do not appear on the agenda.

Councilmember Miller said she has heard the transparency and accountability issue brought up by many Councilmembers and constituents. She said it is important and what Council is supposed to be about, representing the public and letting the public know what is going on so they can be informed. She said transparency and the Open Meetings Act are two very important things that Councilmembers are taught from the very beginning. She said Council is cautioned about communicating with one another, messaging, emailing, etc. She said in the meeting where roundabouts were discussed, there was no lengthy discussion on the subject. She clarified that Council was given an opportunity to continue studying roundabouts and was asked their opinion.

<u>Audience</u>. Councilmember Holman thanked those who attended tonight's meeting and those watching at home. He said there are several University of Oklahoma students in the audience and told them if they live on campus, he is their Councilmember and he would like to hear from them. He said one of his goals is to get more students active in local government.

Miscellaneous Discussion, continued:

House Fire. Councilmember Castleberry said his neighbor and friend's house caught on fire last Sunday. He said the victim happens to be a Norman firefighter who was not at home at the time. He said five fire trucks came to help put out the fire while he and his neighbors watched. He said it was reassuring to see the Norman Fire Department at work and he was impressed with their professionalism. He said the house was fully engulfed but the Fire Department kept the fire contained with no other home damaged. He said the house was a total loss and the family lost everything. He said the firefighter is too proud to ask for help, but he will not turn down help for his children. He suggested donations of gift cards because the family can purchase clothing and shoes and household items. He said many donations have been left at the fire stations and said if anyone wants to help, they can drop off donations at his office on the corner of Berry Road and Lindsey Street and he will make sure the donations get to the family. He asked everyone to keep the family in their prayers.

Norman Regional Hospital. Councilmember Heiple said he, Councilmember Miller, and others met with Staff at Norman Regional Hospital to continue discussion about receiving a price for twenty top medical procedures. He said he got a list, but the list needed to be simplified. He thanked NRH Staff for their help and highlighted some of the prices on the list. He understands it will take time to get a one price procedure list and will continue to work with NRH Staff.

<u>Terra Verde School</u>. Councilmember Heiple thanked Terra Verde School for asking him to speak to the students about government. He said he created a hypothetical zoning situation and asked students to find a solution. He said the students started out opposing the zoning request but ended up finding solutions that were beneficial to the neighborhood by including a park, bike and walking trails, and other amenities. He said the final analysis was that it takes trust and imagination to get people to work together. He said these six, seven, and eight year olds were able to working through the problem and that adults should take a lesson from the students.

Being Wrong. Councilmember Heiple said during a recent purchase of electronic equipment, he had his own ideas of what he wanted and eventually had to admit he was wrong to the store clerk. He said the point of this story was that people get immersed in being right and hold on to the idea of being right all the time. He said federal, state, and local governments fight all the time because they want to be right, but it is okay to be wrong. He said it takes a little humbleness and humility to believe in being wrong.

<u>Park Improvements</u>. Councilmember Kovach thanked Parks and Recreation Staff for improvements to Rotary Park. He said the park looks wonderful.

Mayor Pro Tem Griffith thanked Bill Ulch, Parks and Recreation Superintendent; James Briggs, Park Planner; and Jud Foster, Director of Parks and Recreation, for meeting with 20 citizens to discussion maintenance and problems at Crestland Park as well as future development plans for the park.

Household Hazardous Waste. Mr. Steve Lewis, City Manager, said the 15th annual Household Hazardous Waste event was a huge success. He thanked all the volunteers who worked the event. He gave a brief overview of items collected that included almost 31,000 pounds of electronic equipment; 400 tires; thousands of gallons of motor oil; and ten gallons of prescription drugs. He said without the volunteers the event could not have been a success.

<u>Veteran's Parade</u>. Mr. Steve Lewis, City Manager, encouraged everyone to attend the Veteran's Parade on Saturday, November 9th at 10:00 a.m. The parade will start at the First Baptist Church parking lot and end at Andrews Park. He said 100 parade entries are anticipated and the speaker will be General Harry Bud White, III, Director of the Air National Guard, Washington, D.C.

<u>Traffic Issue.</u> Mayor Pro Tem Griffith thanked Angelo Lombardo and David Riesling, Traffic Engineers, for their assistance in addressing a traffic concern at Rock Creek Road and Sequoyah Trail. He said after a thorough investigation of this intersection, a traffic light will be needed in the next few years, and funds will be included in the Capital Improvements Budget for the FYE 2016-2019 cycle.
