

GRANT OF RIGHT-OF-WAY
City of Norman

Know all men by these presents:

That Fowler Holding Co., for and in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, do/does hereby grant, bargain, sell, and convey unto the City of Norman, a municipal corporation, a public utility easement and right-of-way over, across, and under the following described real estate and premises situated in the City of Norman, Cleveland, Oklahoma, to wit;

A strip, piece or parcel of land lying in the Southwest Quarter (SW/4) of Section Fourteen (14), Township Nine (9) North, Range Three (3) West of the Indian Meridian, Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows (and depicted in attached Exhibit B-Parcel 7):

*Commencing at the Southwest Corner of the Southwest Quarter (SW/4) of Section 14;
Thence North 00°28'36.05" West along the West Section Line of Said Section, a distance of 1,472.23 feet;
Thence North 89°31'23.95" East a distance of 50.00 feet to a point on the Existing Right-of-Way, the same point being the Point of Beginning;
Thence North 89°31'23.95" East a distance of 5.00 feet;
Thence North 00°28'36.05" West a distance of 147.50.;
Thence South 89°31'23.95" West a distance of 5.00 feet;
Thence South 00°28'36.05" East a distance of 147.50 feet to the Point of Beginning.*

Said parcel containing 737.50 square feet, or 0.02 acres more or less, of New Right-of-Way for roadway and utility improvements.


All bearings contained in this description are based on the Oklahoma State Plane Coordinate System and are not astronomical bearings.
