Re: Norman Utilities Authority Norman WRF Phase 2 Improvements Recommendation of Award

Dear Mr. Daniels:

Bids were received for the Norman WRF Phase 2 Improvements project at the Norman Utilities Authority Office at 2:00 PM on March 27, 2014. The bids have been checked for accuracy and for compliance with the contract documents. A tabulation of the bids received is enclosed with this letter.

A total of three (3) bids were received on the project. Archer Western Construction, LLC submitted the low bid for the project in the amount of <u>forty-eight million, eight hundred twenty-two thousand five</u> <u>hundred fifty dollars (\$48,822,550)</u>. The Engineer's Opinion of Probable Cost was <u>fifty-seven</u> <u>million, four hundred twelve thousand dollars (\$57,412,000)</u>.

Prior to receiving bids, Garver conducted a prequalification process. Bids were only accepted from those contractors that were prequalified and deemed capable of executing a project of this magnitude. During prequalification, Archer Western provided detailed information about recent water/wastewater projects with references, shared financial standing, and included a proposed approach and team for performing this work. For your convenience, their project reference check information is attached.

We believe that the bid submitted by Archer Western Construction represents a good value for the Norman Utilities Authority. Contingent upon council approval, we recommend that the construction contract for the Norman WRF Phase 2 Improvements be awarded to Archer Western Construction, LLC.
