

## STATUTORY BOND

KNOW ALL MEN BY THESE PRESENTS:

That we, Leslie Smith Huddad, as Principal, and H.H. Const., a corporation organized under the laws of the State of Oklahoma, and authorized to transact business in the State of Oklahoma, as Surety, are held and firmly bound unto the State of Oklahoma in the penal sum of Forty Four Thousand Seven Hundred DOLLARS (\$44,700), for the payment of which well and truly to be made, we, and each of us, bind ourselves, our heirs, executors and assigns, themselves, and its successors and assigns, jointly and severally, firmly by these presents.

Dated this 7<sup>th</sup> day of September, 2012.

The conditions of this obligation are such, that whereas, the above Bonded Principal H.H. Construction is the lowest and best bidder for the making of the following City work and improvement, viz.:

and has entered into a certain written contract with THE CITY OF NORMAN, dated Sept 7, 2012, for the erection and construction of said work and improvement, in exact accordance with the bid of said Principal, and according to certain specifications heretofore made, adopted and placed on file in the office of the City Clerk of the City of Norman.

NOW, THEREFORE, if the said Leslie Smith Huddad Principal, shall well and truly pay all indebtedness incurred for labor and material and repairs to and parts for equipment furnished in the making of said public improvement incurred by said Principal or subcontractors, then this obligation shall be void. Otherwise, this obligation shall remain in full force and effect. If debts are not paid within thirty (30) days after same becomes due and payable, the person, firm, or corporation entitled thereto may sue and recover on this bond, the amount so due and unpaid.

It is further expressly agreed and understood by the parties hereto that no changes or alterations in said Contract and no deviations from the plan or mode of procedure herein fixed shall have the effect of releasing the sureties, or any of them, from the obligations of this Bond.

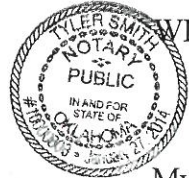
