Stormwater Utility Fee. Ms. Jacy Crosbie, 204 Mountain Oaks Drive, said there was a PowerPoint Presentation shown during the April 1st Study Session about the Stormwater Utility Fee which would be coming up for approval by voters and it should be put on the City's website to allow people to become familiar with it and provide education to the public.

Campaign Reports on Website. Ms. Jacy Crosbie, 204 Mountain Oaks Drive, said when she went to the City webpage and searched "Campaign Forms", one of the search results provided a link that said "City Council Campaign Reports and Forms". She said under this link are the words "This Directory is Empty" but when she opened it, it was not empty and a list of all candidates and campaign reports were listed there. She said this link to information that is vital to voters who want to be informed about the candidates is very misleading and should be corrected.

*

Sylvia Martin. Ms. Ann Gallagher, 1522 East Boyd Street, read a letter from family members of Sylvia Martin thanking everyone for recognizing Ms. Martin at the January 14th meeting. She said the family will be visiting Norman and will having a tribute to Sylvia and Ralph Martin on Saturday, April 26th from 4:00 to 6:00 p.m. at Midway Grocery. She said the family welcomed everyone to attend and share their stories.

Ms. Joy Hampton, *The Norman Transcript*, 215 East Comanche Street, said the first time she came to a City Council meeting, she picked a chair to sit in and was informed that she was sitting in Sylvia's chair and she did not make that mistake again. She said everyone will continue to miss her.

Sound at Meetings. Ms. Ann Gallagher, 1522 East Boyd Street, said the acoustics at the last meeting were better than tonight; however it was great out in the foyer. She said she also knew the project was not completed and there were still issues being worked on.

Consent Docket Items. Ms. Ann Gallagher, 1522 East Boyd Street, said change was sometimes hard for people but when there was a question about an item on consent docket and the person who answers refers to a page in the Agenda Packet, that information is not available to the public to look at. She said it was important to see these items for clarification.

Mr. Bobby Stevens, Post Office Box 6226, said he wrote down items to be discussed and they were not and the reason given is that his subject was not specific enough.

Mr. Roger Gallagher, 1522 East Boyd Street, said because Council wants transparency and wants citizen participation, he felt it was important to allow people to ask questions during consent docket instead of submitting a question on a slip and having it read. He said this was a step backwards and he has not seen many people creating any kind of problem. He said it was obviously Council's decision but if it is a time factor, the person should be asked to watch their time. He said he resorted to asking his questions to Staff members to get answers to his questions and got very good answers.

<u>Campaign Signs</u>. Ms. Ann Gallagher, 1522 East Boyd Street, said the deadline is approaching for removal of campaign signs especially those not posted legally and asked that candidates please remove them.

Use of Bulk Water. Ms. Margaret Walker, 524 West Comanche Street, discussed the use of municipal water by drillers for hydraulic fracking. She said a process that occurs is deep well injection of water that has been contaminated rendering it unusable which is a lack of stewardship over our most valuable resource. She said the citizens of this municipality should have the ability to determine whether or not water is to be used in this way. She asked Council to issue a moratorium on renting any more water meters for bulk water. She asked that Council also consider an ordinance which would not allow the sale of water to any entity that removes the water permanently.

Ms. Mary Francis, 850C Cardinal Creek Condos, said the *Journal Record* has recently published two articles concerning the fracking operation by a Texas Company on a well north of Franklin Road and of the Cleveland County Jail. She said she visited the site and read the meter which said water usage was 8.5 million gallons. She said many cities have enacted better solutions than using potable water for this purpose. She talked to residents in the area and none are happy that they cannot sit outside and listen to birds due to the constant noise and many have questions about whether or not they were notified properly. She urged Council to consider Ms. Walker's suggestions.

Ms. Joy Hampton, *The Norman Transcript*, 215 East Comanche Street, said she understood the importance of water conservation but also understood how important it was to serve all sorts of customers and City Staff has to follow guidelines. She asked if some of the water used for street sweeping was from some of the City wells that is not potable water, could this same water be used for fracking as an alternative.

Councilmember Kovach thanked those who had spoken this evening regarding the bulk water issue. He said Council takes this very seriously and is looking into various solutions.

Use of Bulk Water, continued. Mr. Steve Lewis, City Manager, said part of this issue is governed by City Code which authorizes the City to grant Bulk Water Permits to customers who want to be able to access that source of water. He said a permit application is required to be filled out which is then taken to the Line Maintenance Division and a deposit and permit fee are paid. He said he and the Utilities Director have the ability to set the fees for the deposit and the permit fee administratively but the City Code does not necessarily allow them to set additional conditions on the permit holders. He suggested if additional regulations were wanted, that the topic come before a City Council Committee and ultimately an ordinance with the amendments will be drafted to address the issue. The current charge is \$25 for a permit and the cost for water usage fee is \$2.50 per thousand gallons. He said there are approximately 60 of these types of meters in the City used for a wide array of things. The meters are used by construction companies for soil compaction and dust control, by companies to fill swimming pools, and by not-for profit groups for car washes. He said to put this into perspective, over the last three years, the amount of water that has been used is approximately 1/2 of one percent of total water production in the City of Norman. He said one suggestion had been to use reclaimed water as an alternative for bulk water use; however, the Oklahoma Department of Environmental Quality will not allow the use of reclaimed water. He said the City has some nonpotable water from arsenic wells and a non-fluoride well and this water is used in street sweeping efforts. He said the water could possibly be used but the location of the wells could present an issue because trucking the water would be involved. He said he and Mr. Ken Komiske, Director of Utilities, are looking at different ways to address the issue. He said one issue that should be addressed during drought season the City sometimes purchases water from Oklahoma City and the rates should be raised to cover these expenses.

Mayor Rosenthal said many of the Councilmembers were surprised to learn that this was a routine transaction especially since Council has been asking citizens to conserve water. She said some situations for use of bulk water could send the wrong message to citizens. She said Council will decide which Committee will take this issue and work with the City Manager on some Code changes.

Problem with Debris Removal. Mr. James Lester, 1224 Trout, said he went to the City Clerk's Office and asked about the debris from the ice storm that had not been picked up at his residence. He said on the day it had been picked up on his street, he had been working on cutting up debris and the Contractor and City Truck had driven past without picking up the debris. He said he went to the City Clerk's Office to find out how to get it picked up and was told that the Contractor was no longer in town and nothing could be done. He said since that time, others had put additional items with his debris. He said on March 29th, he received a notice from the City saying he was in violation of Section 12-203, Health Nuisances. He said these items are in the City right-of-way and not on his property. He said now there is a sign in his yard and he has called and visited the City Attorney's Office and Code Enforcement but neither have returned his calls. He said he went to Street Maintenance but could get no help. He said he went out and cut up everything and took it all to the compost facility. He said in the process of cleaning everything up, he stepped on a water meter lid, fell through and injured his leg. He asked for a retraction of the notice and an apology. He also asked if the Street Division would clean out the catch basins on his street.

Mayor Rosenthal asked Mr. Lester that staff would talk with him after the meeting.

Street Light on 36th and Highway 9. Mr. Bobby Stevens, Post Office Box 6226, reported that a street light was out on 36th Avenue S.E. and Highway 9.

Recycling Center on East Side. Mr. Bobby Stevens, Post Office Box 6226, said he had planned to talk during Item 19 on the consent docket, the amendment with the Cleveland County Commissioners for the recycling center on their property, to bring up the fact that in 2006, an Eastside Recycling Center had been promised at the new Fire Station on Alameda. He asked when and if this was going to happen.

Councilmember Miller said there is presently no recycling center in the eastern part of Norman and she is working on getting a center at the new Fire Station. She said she did not know a timeline but expects the center to be up and running soon.

*

Recent Election. Mr. Bobby Stevens, Post Office Box 6226, said recently the Norman Transcript wrote that the voters were misled by a negative campaign which led to a close vote on the Public Safety Sales Tax (PSST). He said he thought the voters had been informed properly and that there had not been enough time to learn all the facts. He said the issue passed and he was happy that citizens voted, whether yes or no. He said he hoped no one held it against those who voted no because he felt the ballot language was questionable. He said he did not feel Ward Five had been properly notified because many of these people have a Noble address which is confusing. He said he supports the PSST but there should be a proper way to get the information out there.

Ms. Ann Gallagher, 1522 East Boyd Street, congratulated all Councilmembers who had participated and all who have served because their service is appreciated.

Councilmember Holman said he always encourages people to vote and approximately 7,500 people did vote in this election; however, the City of Norman has approximately 70,000 registered voters. He said only 10 votes were cast in his precinct but it contains most of the University students and is the lowest voting precinct in Cleveland County. He said Ward 7 historically has the lowest voter turnout in City Elections and turnout for this election had been above average for this election. He would like to work with the University of Oklahoma to make students more aware and to encourage them to get involved.

Councilmember Miller said it is very hard to keep up communication with constituents of Ward Five because there are so many people over a large area of land. She said not everyone has cable to be able to see Channel 20 and unless they have a good internet connection they cannot watch the City Council meetings. She said she is always open to new ideas about better ways to communicate.

Councilmember Heiple said he was happy about the PSST vote because it passed. He said there were 3,801 people who said yes, but he wanted those 3,662 who voted no to know he is listening and Council will watch over this. He said he knows citizens want to trust their City government and Council will do the work by letting them know how the money is spent. He said this was a well-thought out and well-discussed policy and he is proud of it.

Mayor Rosenthal thanked the voters who turned out at the polls because Council appreciates the support, albeit close, to renew and make the PSST permanent. She said the night of the election she told the reporter that the City has had a success story with the PSST approved in 2008. She said the spending of the PSST Fund has been transparent and was overseen with regular reports to the community. She said people should expect the same for the second PSST tax. She said the responsibilities of the PSST Oversight Committee have been strengthened under the new ordinance because it is very detailed how the funds are committed and how the money is to be spent.

*

<u>Plant Gardens</u>. Mr. Evan Dunn, 621 Cruce Street, said he has heard the message about how important the increase in urban food production is. He said he recently planted several fruit trees in yard in Norman. He said he had obtained reading materials about horticulture and raising farm animals to learn how to be self-sustaining. He completed the Master Gardener Program and one of the requirements for completion was performing a certain number of volunteer hours taking telephone calls and answering questions about horticulture. He said the Oklahoma State University (OSU) Extension is a State funded institute that has performed the research that people have access to learn how to plant trees. He said there was a time when people did this for necessity and now it is done out of choice.

*

Gray Water. Mr. Roger Gallagher, 1522 East Boyd Street, said he fully supported installation of gray water systems in new homes. He said a system can be installed for approximately \$2,000 and the builders could charge it back to the homeowner. He said he thought this would save quite a lot of water.

*

<u>Cardboard</u>. Mr. Roger Gallagher, 1522 East Boyd Street, wondered how advantageous recycling with Republic was because one reason they were selected was because they would pick up cardboard to recycle.
