KNOW ALL MEN BY THESE PRESENTS:

THAT, Bethel Baptist Church of Norman, OK, in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, does hereby grant, bargain, sell, and convey unto the City of Norman, a municipal corporation, a Perpetual Sidewalk Easement and right-of-way over, across, and under the following described real estate and premises situated in the City of Norman, Cleveland County, Oklahoma, to wit:

A strip of land being a part of Block 5, LYDICK'S SECOND ADDITION, an Addition to the City of Norman, Cleveland County, Oklahoma, according to the plat recorded in Book 3 of Plats, Page 63 thereof, more particularly described as follows:

COMMENCING at the southwest corner of said Block 5;

THENCE North 89°44'57" East, along the south line of said Block 5 and the north right of way line of Lindsey Street, a distance of 575.00 feet to the POINT OF BEGINNING;

THENCE North 00°16'31" West, along the east line of Lot 1, Block 1, SONIC NO. 1 ADDITION, a distance of 5.00 feet;

THENCE North 89°44'57" East, parallel with the south line of said Block 5 and the north right of way line of Lindsey Street, a distance of 95.22 feet;

THENCE South 00°16'31" East, parallel with the east line of said Lot 1, a distance of 5.00 feet to a point on the south line of said Block 5 and the north right of way line of Lindsey Street;

THENCE South 89°44'57" West, along the south line of said Block 5 and the north right of way line of Lindsey Street, a distance of 95.22 feet to the POINT OF BEGINNING.

Said described strip contains an area of 476 square feet or 0.0109 acres, more or less.
