<u>Development in Norman</u>. Mr. Steve Ellis, 633 Reed Avenue, cautioned Council about picking and choosing who is allowed to develop in Norman because that could create a situation where the City could be overbuilt. He said the competitive environment can drag everyone down and regulations regarding who can do what and when prevent that from happening. He said if development creates empty apartments, that mistake can cost the community.

Mr. Bobby Stevens, Post Office Box 6226, said progress is going to come to the City of Norman.

Councilmember Holman said he agreed with Mr. Ellis on several of his issues.

Councilmember Lang said he grew up in northern California where academics are the people who know better than the free market but this created a huge homeless population and unfortunately while something looks really good on paper, too many times it does not turn out exactly like the academics planned. He said he will always trust the free market more.

<u>Towing Cars During Events at OU</u>. Mr. Bobby Stevens, Post Office Box 6226, said the area of Bishop's Landing is the perfect place to park during events and football games at the University of Oklahoma. He said in 2009 during a concert, the cars were not towed but during football games they are towed. He said with a large parking area, the apartment complex should charge people to park in the empty lot instead of having cars towed.

<u>Flood Plain Ordinance Revisions.</u> Councilmember Miller said this was a very difficult decision and she has concerns about the flood plain ordinance. She said there are a number of items that are not clear which puts Council in a very difficult position. She said flood plain ordinance needs to be revised to address all the concerns in core Norman and the Flood Plain Committee needs to be ready to work on it.

<u>Payment to City Council</u>. Councilmember Holman said he worked on his taxes this weekend and before taxes, his compensation for being on City Council was \$1,200 before taxes which came out to approximately .09¢ per Norman resident. He said Council cares about Norman and would do this for free if they had to.

<u>12th Avenue S.E.</u> Councilmember Holman said Council received word that allocation of transportation funding for the Norman area did really well but the 12th Avenue S.E. Project from Highway 9 to Cedar Lane did not make the cut again this year. He said City Staff is working on some possible solutions in the interim.
