MISCELLANEOUS DISCUSSION

Norman Regional Health System (NRHS). Mr. Bryce Ell, Healthcare Administration, Norman Regional Health System, thanked everyone in the room for staying. He said no healer in this room is being paid overtime or receiving any pay whatsoever to be here. He said they are not being forced to be here by their leadership. He said they are here for three reasons: 1) We believe in the mission, the Inspire Health Plan, and that Inspire Health Plan perpetuates the mission of Norman Regional Health System to be a leader in health and wellness for the City of Norman and for every citizen of Norman. 2) We are committed to the City of Norman; and 3) We are Norman; we are the community. He said he fell in love with this organization because it is a community hospital.

Councilmember Hall said she supports the plan but it is critically important to the community to let everyone know about what NRHS has been working on for two years. She said it is equally important to dispel and help citizens understand some of the uncertainty of the future of the Porter Campus. She thanked hospital leadership and staff for the time they spent with City Council during the last few weeks.

Councilmember Petrone said she sees it like Councilmember Hall sees it and hopes NRHS will embrace this and get more community input. She said a little more time is needed to get the community on board. She said her ward will be benefitting from this initiative because the Healthplex is in Ward 3. She said Councilmembers had received several calls and questions that Council could not answer and she appreciated the answers tonight.

Councilmember Bierman said there are several events and ward meetings coming up where NRHS can engage the public about Inspire Health. She said none of the questions or discussion tonight should have been taken personally and she felt Council had taken great pains to make sure NRHS knew that. She said she wants to like this plan and with a little more time to look into things deeper and to engage her constituents, she can get there. She said City Council realizes what important work NRHS does. She said she is thankful for all the calls and emails she has gotten because it has given her a great perspective from the provider's side.

Mayor Clark said she could see from the audience's faces that they were taking it personally and that is OK because Council cannot tell them how to feel. She said she knew it was not the outcome they wanted but she also knows her colleagues are just doing their part to provide opportunities for their constituents to engage.
