MISCELLANEOUS DISCUSSION

Marijuana Ordinance. Ms. Lauren Lackey said pre-rolled marijuana is considered processing because the flower is manipulated and paper is added. She said there is a massive size and scale difference between growers and processors. She said some processors are doing full chemical extractions of large quantities of marijuana and there are processors who are purchasing the product made by processors and adding it to baked goods and spraying it on products; therefore, the fees should be different depending on what is done and it should be considered when deciding how it should be zoned. She said the zoning process takes approximately three months and to be business friendly, an emergency meeting should be called to get it done faster. She asked if someone has already paid for their license which was \$100, will that fee be valid until March of next year or do they have to purchase a new license when the new fees are approved.

Ms. Brenda Hall, City Clerk, said it will be valid until renewal date of March 31st.

Mr. Robert Husky, 3615 Chatham Court, asked who was going to pay the staff to do the research Council is asking for. He said this research is above and beyond what staff ordinarily does. He suggested that staff bill the City Council.

Mr. Lucas Watson said he has talked to a lot of Medical Marijuana business owners recently and no one is really opposed to paying a fee, they just want the fee to be fair and equitable. He said these owners live and work in Norman and they want the City to be solvent and for there to be money to pay for sidewalks and low cost spay neuter. He thanked Mayor Clark and Council for being so reasonable and open to trying to get the right thing done.

Miscellaneous Comments, continued:

<u>PAL Program</u>. Ms. Ann Gallagher, 1532 Woodsong Drive, said she is fortunate to be a volunteer for the Police Activities League (PAL) for incoming 7th and 8th Graders who were recommended by the Student Resource Officers or counselors at their schools. She said it was an amazing experience, one she will continue to do. She said the community partnership is very important throughout the camp. She said not only do the campers have the values of the Police Department which includes integrity, accountability, mutual respect, service attitude, and partnerships, they were able to experience things they do not normally get to experience. She said they went to Salvation Army and did cleanup; Meals on Wheels to wash cars for the drivers; the Women's Sanctuary City to make packets; the Animal Welfare Center; and Second Chance. She said the camp provided an attitude of service and the instructors were amazing. She said there were a minimum of ten volunteers and of those ten, seven were Citizens Police Academy alumni. She said it is important to support community partnerships. She said one activity was going to Benvenutis for lunch and learning table manners. She said the young people showed respect to the officers and the growth that they made was amazing to watch. She said graduation was April 2nd in Council Chambers and thanked Councilmember Scanlon and Mayor Clark for attending. She encouraged people to attend next year.

Councilmember Scanlon said he was privileged to be a part of the PAL Program which is an incredible program. He said on the second day of the event Mayor Clark gave a speech that captured the students' attention and both the students and parents expressed to him how moved they were by the Mayor's words and experiences. He thanked all the volunteers for the donation of their time to the program as well as the community partners that sponsored the event. He said the Citizens' Police Academy (CPA) graduates participated, both financially and with their time.

<u>Sidewalks Obstructed</u>. Mr. John High, 1705 Dakota Street, said bushes and trees are overgrown and blocking sidewalks all over town. He asked people to cut back their bushes and branches because no one likes to get hit by an overhanging limb. He also asked people to please not block the sidewalks with their cars when they park in their driveway.

<u>Residential Lighting</u>. Mr. Larry Steele, 730 Hoover Lane, asked Council to keep the residential lighting ordinance on the back burner.

<u>Mass Shootings</u>. Mr. Evan Dunn, 1400 Garfield Lane, said everyone owes Mayor Clark a thank you for taking a stand regarding the recent mass shootings. He said something has to be done which he knows will not stop them because there are 400 million guns in this country. He said the culture is fundamentally the problem.

<u>Code Violations</u>. Mr. Evan Dunn, 1400 Garfield Lane, said on Tonhawa Street there is a cute little bungalow Airbnb and the entire front yard is full of growth at least three feet high. He said if we let our grass grow like that we are reducing the expenditure on energy to mow it and maintain it. He said City Council should eliminate the requirement that grass over 12 inches high is a nuisance and remove the prohibition against parking in the yard.

Senior Citizens Day. Mr. Paul Arcaroli, 405 Garland Court, said he appreciated the proclamation for Senior Citizens Day. He said it is actually International Senior Day. He said President Reagan taxed senior citizens in 1984 and increased the retirement age from 66 to 67. He said maybe the Mayors will get together and write a letter suggesting we actually deal with the future crisis with income security for seniors.

Miscellaneous Discussion, continued:

<u>Safety Issues.</u> Mr. Jack Dawson said he would love to bring some kind of proposal about safety to City Council and the City Council would vote on a resolution on certain issues to send the state legislature.

Councilmember Scott said Mr. Dawson was referring to a gun control resolution to be sent to the state because cities will be pre-empted in November when statewide permitless carry takes effect. She said Staff is reviewing actions the City can take in parks and on other City properties to keep our citizens safe.

Mayor Clark said she and her husband are gun owners and gun control does not equal taking guns away. She said her recent comments on gun control was a way to ask for suggestions on keeping the community safe as Oklahoma approaches Constitutional Carry in November. She is pleased to report that Council will be working with the City Manager and Chief of Police to host one free gun safety class because the City wants citizens to be educated on how to use guns.

*

<u>Ward Meetings</u>. Councilmember Scott said the most recent Ward 8 meeting was very successful with excellent presentation from Staff about NORMAN FORWARD projects. She said the next meeting will be September 29th to discuss environmental issues, such as Ready for 100 (renewable energy).

*

<u>Council Decisions</u>. Councilmember Holman said he knows that many people believe Council makes decisions on items on the agenda and that it is worthless for them to come to meeting to talk to Council about their opinions. He said this is not true because many times Council deliberate and some Councilmembers change their mind about an item after hearing public discussion or other Councilmembers opinions on an item.

Councilmember Scanlon agreed with Councilmember Holman and said Council depends on public input because it is so important so please keep it up.

Councilmember Wilson said she changes her mind on items when the public weighs in, so she agrees that public input does make a difference in Council actions. She said the public sometimes make good points that Council has not considered.

*

<u>School is Starting</u>. Councilmember Holman reminded everyone that school is about to start and in Ward 7 students are already parking their vehicles along the streets and pedestrian traffic is picking up. He said those who need to go to work or run errands please remember there are a lot of students in Norman that come from small towns and do not deal with a great amount of traffic so they may not be paying attention so drivers need to pay attention for them.

Mayor Clark said when drivers get frustrated about the lack of student parking and pedestrians, please remember three words, "sales tax,revenue."

<u>Parking Issues</u>. Councilmember Holman thanked City Manager Darrel Pyle for helping to address fraternities and sororities that have limited or no parking. He said the City Manager was able to meet with fraternity/sorority leaders and the University of Oklahoma (OU) regarding the issue and they were able to find a church that would allow students to park there.

Miscellaneous Discussion, continued:

<u>National Night Out</u>. Councilmember Scanlon said he was able to attend eight out of the twelve parties in Ward 6 at National Night Out on August 6th and he really enjoyed meeting his constituents and getting feedback from them. He said there was also a first time National Night Out event at Andrews Park and if the merit of success is based the number of ice cream cones served there were 300. He said this was a great opportunity for people to participate who may not have a neighborhood event.

Mayor Clark said National Night Out was a success and thanked everyone that participated. She said there is a general consensus to have National Night Out in October next year.

<u>Animal Welfare Center</u>. Councilmember Wilson said the Animal Welfare Center received 21 puppies and needs supplies. She said some of the puppies are as young as two weeks old and are being bottle fed while some are four weeks old and are on a mixture of canned food and formula. She said they need canned food, canine milk replacer, old towels, puppy pads, bottles, etc. She said most of all the puppies need a foster home so if anyone can foster a puppy it would help greatly. She encouraged everyone to be responsible and spay or neuter their pets.

<u>Cherokee Nation</u>. Councilmember Hickman said he will have the honor of visiting the Cherokee Nation tomorrow for the inauguration of the new Chief and Councilmembers. He suggested Council prepare an acknowledgement resolution out of respect to the sovereign Native American Nations whose jurisdictions overlap Norman's as well as take action to strengthen the City's bond with the local tribes.

<u>College Students</u>. Councilmember Hickman said his daughter, Emma, will be starting college at Creighton University in Omaha, Nebraska, and gave her a shout out. He is excited for her, but at the same time will miss her.

Councilmember Petrone said her nephew is starting OU this year and she is excited for him.

<u>Women's Equality Day</u>. Councilmember Petrone said she was able to participate in some Women's Equality Day discussions and enjoyed learning the history of equality for women.

<u>Federal Emergency Management Agency (FEMA).</u> Councilmember Petrone said FEMA meetings will be held on August 22nd at 5:30 p.m. and September 4th at 5:30 p.m. in the Council Chambers and encouraged everyone impacted by the new FEMA floodplain boundaries to come to these meetings.

<u>Progress</u>. Councilmember Bierman said progress has made an important impact on everyone's lives, such as the invention of the motor vehicle, cell phones, renewable energy, expanded human rights, etc., but there is no intellectual or academic focus on the study of progress. She said there are still diseases that have not been cured and end lives early, no one can predict or mitigate natural disasters, people cannot travel as cheaply or efficiently as they would like to, but progress can come in large leaps or it can be an accumulation of a thousand small moments that represent a monumental shift in life.
