Thanks for allowing us to provide you with an "estimate" for your repairs. We try to write the estimate as close as possible to the visible damage and what can be surmised by (X Ray) experience what may be hidden. Some shops just write a quick estimate to get the car in and Supplement later. The unsuspecting consumer or Insurance Company is left with a much larger bill. This is a common practice among some shops and collision repair facilities. Some damaged areas or procedures may be missed in writing the estimate. In addition other parts or labor items maybe discovered after the car repairs are under way and need replacement according to the original standards set by the manufacturer of your vehicle.. If however, any unforeseen items are discovered during the repair process we will contact the insurance company and/or you to explain the circumstance. Manufacturers often change prices without notification and may change the estimate totals. This "estimate" does not constitute a one party contract. Please be assured that most repairs are completed without changes to the original "estimate."

If there is an insurance claim involved, they may desire to have their own adjuster look at your vehicle. That estimate may be different. Working from the Insurance claim and estimate will give us the opportunity to adjust the repair costs and supplement those costs back to the insurance company. This process is usually simple and requires very little from you! If the repairs are accomplished from our estimate only, any additional costs will be the owner's responsibility to finalize.

It is our desire to make a lifelong customer. Additional repairs added to the repair require increase in the Final Bill. Anything not on the estimate is additional.

In preparing to leave your vehicle with us, please be sure to remove any personal items. Repairs sometimes require access to the trunk or interior areas, damage or loss can occur when those items are removed. WE ARE NOT RESPONSIBLE FOR ANY ITEMS LEFT IN THE VEHICLE.

It is not necessary, but it will be helpful to wash your car before dropping it off for the repairs. This will allow us to mark any damage not related to the repairs being authorized. Be assured that we will take the necessary steps to perform quality repairs on your vehicle and return it to you as soon as reasonably possible. Be assured that all of our repairs carry factory warranties on all parts and paint. Any labor items are warrantied for the repairs we complete. Should you have any questions, please feel free to give us a call.

Our Technicians are ASE and ICAR trained to provide excellent repairs to our customers. We use the highest quality materials, professional technicians and quality equipment to complete your repairs according to those standards. No sub-standard parts are used in our repairs. Storage, \$20 per day will accrue on all unrepaired vehicles from date of arrival until vehicle has been disposed of by owner or shop.
