### MISCELLANEOUS DISCUSSION

<u>DeBarr Avenue Resolution</u>. Ms. Linda Mendoza, 210 East Haddock Street, thanked Council for moving forward tonight. She said there is a way to work toward solving the problem and was gratified to know that Council agreed that the name change needed to happen. She said the citizens of Norman have a greater voice than just the people who live on DeBarr Avenue and it was very important for the tenants and property owners to participate. She invited them to come to the November 8th Oversight Committee meeting to represent their own views and hear everyone else's views.

Ms. Marla Turner thanked everyone for their time tonight and said she was pleased the resolution was adopted. She expressed concerns about the lack of participation from the residents on DeBarr Avenue. She asked that Council not pat themselves on the back for doing something that should have been done long ago. She implored Council to do their best to get this done.

Mr. Casey Holcomb, Ward 4, said he appreciated the actions taken tonight; however, it was regrettable that it took this much effort to make it happen. He urged Council not to use this to sell themselves.

Ms. Tamara O'Toole thanked Council and everyone who came to the meeting. She said this might seem like an end to things but she really feels this is a good beginning.

Ms. Ashley McCray, Ward 4, said before anyone uses approval of the resolution as a platform please remember there was a lot of resistance on this issue. She thanked everyone who was open and willing to listen in order to move forward in a good way. She said it is reprehensible that Councilmember Karjala did not speak on this issue especially because she is running for the Oklahoma State Senate. She said those who came tonight are justified in their anger, which is from tangible experiences and consequences related to inherent racism that exists and has been perpetuated through living in a "Sundown" and "Land Run" City.

Mr. Bob Husky, 3615 Chatham Court, said Councilmember Karjala did speak tonight, she voted, which spoke louder than anything else. He applauded all of the Councilmembers tonight although this probably could have been done without all of these words, but all of the words were extremely important for all of us.

Ms. Sarah Banna said it took the citizens to make Council do the right thing. She expected an apology from the City Council because they did not take responsibility for what has been happening under their watch.

Councilmember Bierman said she was happy to see everyone here tonight to express their views.

Councilmember Karjala said she has been trying to cultivate new skills while being on City Council and one reason she did not speak tonight is that she is trying to be a better listener. She said tonight she did not feel like she had as much to offer to this topic and she wanted to learn. She said she is sorry that offended some of the people in the audience.

Miscellaneous Discussion, continued:

### DeBarr Avenue Resolution, continued.

Councilmember Castleberry said as uncomfortable as these meetings may make some people, he thinks they are awesome. He likes the fact that everyone came and talked to them tonight. He asked when people have issues, please contact Council. He said all of the Councilmembers vote and asked people to please reach out to him whether they live in his ward or not. He said he appreciates all of them coming tonight.

Councilmember Hickman said he appreciated everyone's input this evening. He assured people that he had not just been talking to the people on DeBarr Avenue, but many people throughout the City.

Councilmember Wilson said she is grateful for Mr. Osborne's words this evening and appreciates everyone coming out tonight She said she did not know anything about Edwin DeBarr until this came up. She said she remembers seeing Ku Klux Klan members and White Supremacists on television as a teenager and being so very angry. She loved hearing the stories tonight. She wants this issue taken care of so no one will have to go through this again.

Councilmember Clark thanked everyone for attending and for their efforts. She said this is not a student or property owner issue, it is a community issue. She feels Council is on the right path to make the change. She said she has a hard time accepting the credit that people are trying to give her tonight because she is only one vote and this passed unanimously. She will always be proud of this moment and commended the audience for sharing their painful stories. She said she would see everyone at the Oversight Committee Meeting on November 8th because they were not finished yet.

Councilmember Holman said he thinks recognizing the problems that the city of Norman has had and trying to correct them is something that has made Norman different than other places. He said not everything has been fixed and Council does not always get it right but they try. He promised not to let everyone down. He thanked everyone for coming and sharing this evening.

Councilmember Allison agreed with everyone tonight and said that this meeting was very informative. He said he has lived in Norman for almost all of his life and had no idea about the history of DeBarr Avenue. He said every night that they come to a Council meeting, they learn something new and it is a great civic experience. He urged people to serve on committees, give back to their community, and stay involved.

Mayor Miller said this evening there were individuals that had hostile feelings about some of the things that some of the Councilmembers had done or said. She wanted everyone to know that these Councilmembers work very, very hard for their wards. They try to listen and do what's right all of the time. She said, yes, we all mess up from time to time, but all are spending a tremendous amount of time doing the work of City government. She said she appreciated Mr. Osborne's leadership and the fact that he worked to get a lot of this together as well as several others. She said she believes they are on the right path.
