# MISCELLANEOUS DISCUSSION

<u>Approval of Item 19, Resolution R-1617-51</u>. Mr. Steve Ellis, 633 Reed Avenue, said he was disappointed in the cavalier attitude of Council to go against the City Charter by adopting a resolution that changed the filing dates. He said he feels that this opens the City up to a lawsuit.

Ms. Kate Bierman, 209 Ridge Lake Boulevard, said she is very disappointed because the time has been shortened between filing and the election. She said many people who want to run do not know about this change.

Ms. Cindy Rogers, 633 Reed Avenue, said she was surprised how Council voted and feels it discourages participation because it is a huge commitment to run. She said she appreciates the Councilmembers who voted no

Councilmember Hickman said he respected all Councilmembers who supported the resolution even though he voted against it.

Councilmember Holman said he appreciated the debate tonight and that it was unfortunate that Council did not have time to discuss this because it will affect candidates and voters. He said the City Charter mandated the filing period and since he is a candidate he will be ready but he would like a regular schedule every year. He said in the future, Council needs to consider a charter amendment.

Councilmember Castleberry said he had been working on this issue for the past two days and takes it very seriously. He said the decision had to be made tonight or he would have been more than willing to postpone it. He said the City Attorney is an expert in municipal law and Council has been told that state law supersedes the City Charter. He said he is satisfied that everything Council did this evening was legal. He said the issue needs to be resolved and a committee can work on an amendment if Council decides that is what they want to do. He said the State could change the law again so there has to be flexibility in the charter to handle those types of changes.

Sherwood Construction. Ms. Cindy Rogers, 633 Reed Avenue, said she appreciated the time Mr. Shawn O'Leary, Director of Public Works, spent in responding to all her questions about illegal dumping by Sherwood Construction.
