Homeless Situation. Mr. Steve Ellis, 633 Reed Avenue, said there had been several discussions recently about Norman's homeless situation and the need for a variety of services during the recent cold weather for citizens who are without shelter from providing emergency shelter to transitional housing. There are people who are interested in finding a replacement for East Main Place, which has been closed and have suggested developing something in University North Park TIF District. He said that area has quite a few job possibilities. Norman is cash strapped in regards to the General Fund but the TIF Fund might be a funding source.

Councilmember Castleberry acknowledged that there are several Councilmembers as well as the Mayor working together to solve the homeless issue during the recent cold weather. He said our friends at Food and Shelter for Friends are working doing a great job to meet the need and he encouraged that agency to continue working towards the long-term goals of building a larger facility. He commended Journey Church who is opening up Loveworks in the downtown area, which will be open from 8:00 p.m. to 8:00 a.m. to provide shelter for the homeless. He said he knows several other churches and social services are working behind the scenes to help people out.

Councilmember Kovach said a few years ago, Council provided emergency funding to several agencies, including Food and Shelter for Friends, who provided emergency shelter to many homeless people. He proposed that an emergency fund be set up for this issue to be used every year during these types of situations. He asked that this item be added to the Finance Committee Agenda.

Councilmember Heiple said he was told recently that Food and Shelter for Friends was out of funding and needed help to help the homeless. He said the director called *The Norman Transcript* and an article was published and people came forward with funding. He commended *The Norman Transcript* and everyone who came forward.

Mayor Rosenthal said there is an active coalition called "One Vision One Voice" consisting of various providers who work with homeless people from high school students to those who need emergency shelter. She said this kickoff of this coalition will be later this month for the purpose of providing services for those in need in our community.

*

Funding for Utilities for Organizations. Mr. Bill Hickman, 517 Macy Street, said it had come to his attention that Council had cut funding for the utilities for some of the arts programs and service organizations. He asked Council to reinstate this funding for the rest of FYE 2014.

Councilmember Castleberry asked if the Finance Committee could have included on their agenda an item to discuss the possibility of continuing payment of the utility costs of the social service agencies.

School Bond Election. Mr. Roger Gallagher, 1522 East Boyd Street, said he was the 67th person to vote in his precinct today out of 2,700 voters for the Norman Public School Bond Election. He said he did not know how to encourage people to make the effort to go out and vote.

Center City Visioning Committee. Mr. Roger Gallagher, 1522 East Boyd Street, said he had attended the Center City Visioning Committee Meeting and asked if the purpose was to change an area into something entirely different. He has been told that the purpose is to improve the area from campus to Front Street in downtown Norman. He said he has heard many comments such as the Committee is looking to create "infill" and the possibility of building high density buildings in this area to make the area less auto-friendly. He said this area is an established neighborhood and not blighted and asked what the goal of the committee is. He said he had reservations about the process. He said the University of Oklahoma does not own any of this property and wanted to know why the University was part of the partnership.

Annual Report. Councilmember Miller said Council had received an email from the City Manager announcing that the Annual Report has been released and would be placed on the website soon. She commended all who worked on the many projects that transpire throughout the year, staff, Council, and those on all the boards and commissions because much gets done due to their service.

Curbside Recycling Program. Mr. Steve Lewis, City Manager, provided an update of the curbside recycling program. He said the new recycling contractor had provided a 95 gallon polycart for collection, modified the City's collection frequency to every other week, and expanded collectible materials to include cardboard and chipboard. He said as a result the participation rate had increased 79% with 440 tons per month collected compared to 300 tons per month. Collection to the drop off centers had decreased as well. He said Staff is presently working on a pilot program for multi-family.
