# MISCELLANEOUS DISCUSSION

Property on East Main Street. Mr. Bobby Stevens, Post Office Box 6226, said at the last City Council meeting he had requested the walls surrounding a building that had been torn down on East Main Street be painted because it was unsightly. He said nothing had been done to the building and the building should be painted soon with the 89'er Day Parade and the Music Festival coming in the next few weeks, which would bring many new people into our City. Councilmember Gallagher said Mr. Stevens had pointed out a few places in the City where artists have used their talents in a positive manner and although the building is privately owned but it is possible that the owner would not object to someone beautifying he property and someone should ask the owner for permission.

Ditches on Cedar Lane. Mr. Bobby Stevens, Post Office Box 6226, said Cedar Lane between 36th Avenue S.E. and 48th Avenue S.E. was being widened and some of the ditches will be cleared out and he had been called by several people residing in that area asking what was being done. He said it would be helpful for the City to notify all the residents where were affected by the improvements.

Risser Zoning Items. Mr. Steve Ellis, 633 Reed Avenue, thanked Mr. Sean Rieger for postponing the Risser zoning items with the rationale offered for postponing the items was to allow tracking of the high density discussion. He felt postponing these items preserves some latitude to get around the High Density ordinance. He said these items are not waiting for the approval of the High Density ordinance and he hoped Council would commit to requiring High Density proposals that come before City Council to meet the actual requirements of the ordinance. He urged Council to vote against these items when they finally were considered.

Ms. Jayne Crumpley, 423 Elm Avenue, said that Norman Economic Development Coalition (NEDC) owns a building on the property where this project is proposed. She said she understood that Mr. Risser has an option on that building and is confused about who actually owns the building. She said NEDC is funded through four sources, one of which is the City of Norman and assumed that money was used to buy the building. She said she would like to understand more about the City's involvement with NEDC.

Mayor Rosenthal said the appropriate person to answer that would be Don Wood, Director of NEDC, and Staff would contact Mr. Wood and follow-up with Ms. Crumpley.

Councilmember Gallagher said the City is giving taxpayers' money to NEDC and felt this is a very important question that should be answered.

Recent Rainfall. Councilmember Kovach said he knew everyone was grateful for the recent rain Norman has received but reminded residents that the lake is down over 12 inches and water conservation should continue until circumstances change because the City is still in drought cycle. He asked for everyone's cooperation to help with the long-range water supply.

Councilmember Spaulding asked how much had been added to the lake after the rainfall. Mr. Steve Lewis, City Manager, said the lake had an additional 16-inches after the recent rain event.

Inclusive Community Dialogue. Mayor Rosenthal thanked citizens who participated in the Inclusive Community Dialogue held last Thursday, April 4th, at the Norman Public Library. She said this dialogue focused on issues related to accessibility in the community. She said there was a great turnout from agencies and a strong representation from the community. She said she appreciated the City Staff present and said topics focused on transportation, sidewalks, and housing that is handicap accessible. She said a report will come back to Council from the Human Rights Commission because there are major issues to be considered.

# CITY MANAGER'S REPORT

Sales Tax Update. April remittance has been received reflecting sales that occurred in February, 2013. Sales Tax has increased 3.2% over April, 2012, levels. Year-to-date, sales tax is up 3.3% over last year's totals.

Animal Shelter Project. Bids for the Animal Welfare Center Expansion Project will be received on April 25th at 2:00 p.m. and the bid for construction will be considered by City Council on May 14th. Construction of the project is anticipated to begin June 1st. Services will be provided during construction and the project should take about 12 months.

Park Improvements. New bleachers are being installed at the softball and baseball fields at Griffin Park. Improvements to the concession and restroom buildings at Reaves Park is underway. Walking paths and soccer goals are being added at Sunrise, Colonial Estates, and Colonial Commons Parks with funding approved by voters last year which allowed the pre-1994 parkland acquisition funds to be used on park developments near those areas.

Spring Cleanup. A reminder to residents that yard waste is not picked up during Spring Cleanup. Some of the things that are not picked up are bricks, broken concrete, lumber, sheetrock, shingles, junk cars, or any type of hazardous waste such as tires, batteries, and paint. Saturday, April 20th will be the rural disposal event at two locations, the American Legion Building north of Highway 9 on 156th Avenue N.E. and at Denver Corner, 10800 East Alameda Street.
