<u>CARE Grants</u>. Councilmember Bierman said she had spoken to two people who administer grants and they offered suggestions about the selection process. She said before the selection process begins, all applications should be done "Blind"; with no applicant's name and no business name on the application. This will ensure that the people selecting the grants are impartial. The second point is that Council and the public should be informed of who will be receiving the grants in order to remain transparent.

Mr. Darrel Pyle, City Manager, said he and Sara Kaplan, Retail Market Coordinator, had previously discussed this and absolutely agree about the "Blind" process.

COVID-19 Testing. Mayor Clark said she had received information from the Cleveland County Health Department regarding COVID-19 Testing. She said the extra CARES money provided to IMMY for COVID-19 testing will run out on Thursday, December 3rd. She said last week IMMY tested 32,000 people. She said after December 3rd there will be no free testing for our residents. She asked IMMY how much money it would take to get through the month of December and was told \$2,000,000. She said the cost for testing is \$135 per test. She plans to reach out to our partners at Cleveland County to see if they have extra CARES funding. She said the Health Department had told there would not be another round of funding.

Mr. Darrel Pyle, City Manager, said he reached out to IMMY last month to see how much testing could be done with the remaining CARES funding and asked how many tests could be done for \$1,000,000. He said the response from IMMY was that there was another round of CARES money coming and to save our money. He said that additional money was gone after 4 weeks because many people went to be tested before they joined their families for Thanksgiving.

Councilmember Petrone said the cost at Norman Regional Health Systems is \$65 per test and she was told they would be more than happy to partner with the City to do testing. She asked if the Veteran-Owned and Women-Owned businesses that apply for the CARES grant would be categorized as a minority. She said it was important that Non-Profits be included in the grant process.
