

RE: Norman Regional Hospital PUD Proposal

Dear Commissioners:

We own property at 2317 Bretford Way. Our property's northern boundary is adjacent to the property on which the Norman Regional Hospital System is proposing to build a new campus and a commercial development. We would like to formally protest this development given our concerns below:

- 1. Their proposal does not match what was shown to the HOA or Council previously. This is a full blown commercial development.
- 2. The service road that goes along all of the houses on Bretford Way is unnecessary and will be a nuisance. These roads are commonly used as rest stops for truck drivers and other illegal activity. It is where dumpsters are going to be placed, which means trash will collect against the fences of nearby homeowners. We request this be removed from their site plan.
- 3. The applicant told neighbors they were putting senior living along 24th, however they have included in their PUD document that the residential component of their development will meet RM-6, Medium Density Apartments, one of the densest zoning districts allowed by the City. This is misleading neighbors as to what will be developed.
- 4. The applicant told neighbors the development would all be one story but their PUD document states all development may be two stories.
- 5. The PUD document only requires 30' between the commercial developments and the neighboring residential properties on Bretford.
- 6. The PUD document only requires a 6' wood fence between the development and the neighboring residential properties on Bretford. We demand a decorative masonry fence along with a wide properly landscaped buffer.

We feel the Norman Regional Hospital System is meant to be a community partner; however, they have repeatedly changed their plans and have made false commitments to neighbors.

While we and other neighbors might support a hospital location on the corner with a large green space between the development and the residential properties, we cannot support a large scale commercial development that will create traffic, noise, trash, and other issues. The City is full of retail and office space that sits empty. Creating more retail and office spaces will only perpetuate the issue. Planning Commission and City Council should prioritize infill over developments of this size in primarily residential areas. Please consider our requests when voting on this proposal.



Dear Members of the Planning Commission:

I am exercising my right to protest the proposed 30-acre commercial development by the Norman Regional Hospital Authority (NRHA) which is located at the southwest corner of the intersection of State Highway 9 and 24th Avenue SE.

My protest includes and is not limited to the following:

- 1. Residents of Pebble Brook housing addition and St. James Park housing addition, of which I am a homeowner, were not adequately informed of the project nor were we involved in any way in the planning, proposal, design, etc., of the proposed development.
- 2. The dramatic increase in: noise from sirens; light pollution; traffic at Highway 9 and 24th Avenue SE, an already dangerous intersection; potential traffic accidents; added traffic through the neighborhoods; added traffic and noise from delivery vehicles and trash vehicles on the site.
- 3. The negative impact in the quality of like of the proposed development specifically on the residents of Bretford Way which backs up to the proposed development.
- 4. The lack of the formation of a Neighborhood Advisory Committee by the NRHA which was promised to the homeowners of St. James Park.
- 5. The potential negative effect on property values in St. James Park by the development.
- 6. The increased traffic and potential for more accidents at Ann Branden Blvd. and Classen Blvd. which is already a very dangerous intersection.
- 7. A seeming disregard for locating the proposed development in an area that is not primarily residential.
