

Subject: Response to March 24, 2014, Complaint

Background

On March 24, 2014, William Hickman, challenger for the Ward 4 City Council seat, filed a complaint with the Norman Election Commission ("NEC") against incumbent Councilmember Greg Jungman claiming that he "used his office to endorse his candidacy by using publicly funded, public property (emails) to promote his campaign for office. Attached are emails - one from the Ward 4 public account, which contains campaign information and was sent using private emails received for public purpose." The NEC has requested a formal legal opinion regarding the complaint.

Discussion

Chapter 7.5 of the Norman City Code addresses Municipal Elections. Article II of that Chapter is entitled, "Campaign Disclosures of Contributors, Contributions, and Expenditures." The duties of the NEC are set out in § 7.5-26 as follows:

Sec. 7.5-26. – Duties of the Norman Election Commission.

In addition to any other duties designated by the terms of this article, the Norman Election Commission shall:

- (1) Enforce the provisions of this article;
- (2) Cooperate with the City Clerk in preparing the design and content of appropriate forms for campaign statements required by this article;
- (3) Cooperate with the City Clerk in the preparation and publication of written instructions explaining the duties of person and committees under this article;
- (4) Determine whether the statements required to be filed under this article and also the statements required to be filed by the State Statute in the Office of the City Clerk have been properly filed;

- (5) To review, compare and examine for inconsistencies or other deficiencies all statements filed in the Office of the City Clerk, including forms required to be filed under this article and also State forms required to be filed in the Office of the City Clerk by the applicable State Statutes;
- (6) Investigate any substantial discrepancy, including, but not limited to, total expenditures listed in campaign statements filed before the election and expenditures listed in statements filed after the election;
- (7) Make a public report to the City Council within forty (40) days after the Municipal Election and ninety (90) days after the final election, including, but not limited to, ongoing investigations, violations of this article and violations of the election laws of the State of Oklahoma;
- (8) Recommend or advise the City Council on possible changes as needed to this article;
- (9) Make an effort to inform the public about the importance of reporting all contributions and expenditures by candidates for local offices as well as the political action committees (PACs) involved in a given campaign.

Section 7.5-26(a)(1) grants the NEC the authority to "[e]nforce the provisions of this article." Likewise, § 7.5-27(a) provides the procedure for filing and responding to a "violation of any portion of this article."

It appears that the gist of Mr. Hickman's complaint as it relates to Chapter 7.5 of the Norman City Code is that City resources were used to further Councilmember Jungman's campaign for re-election to the Ward 4 City Council seat that perhaps were not included in campaign expenditure reports required by that Chapter of the City Code. It has been confirmed with Councilmember Jungman and through review of Ward 4 e-mails contained on the City of Norman network that City resources were not used to disseminate Councilmember Jungman's Ward 4 campaign materials.

Recommendation

Having found no factual basis for a violation of Chapter 7.5 of the City Code as alleged in Mr. Hickman's complaint, it is recommended that this complaint, as it relates to possible violations of Chapter 7.5, be closed.

Dear Mr. Hickman:

We are in receipt of the written Complaint you filed on March 24, 2014. As you are aware, we requested legal advice from the City Attorney's Office regarding the alleged violations of Chapter 7.5 of the Norman City Code, the Chapter of the Code over which the Norman Election Commission ("NEC") has jurisdiction. See § 7.5-26(a)(1) and § 7.5-27(a), providing the NEC authority to enforce the provisions of, and respond to alleged violations of, Article II of Chapter 7.5, which is entitled, "Campaign Disclosures of Contributors, Contributions, and Expenditures."

The City Attorney's Office provided the NEC with a June 16, 2014, memorandum, addressing the factual and legal concerns raised in your complaint. That memorandum is enclosed here for your records.

Following the advice of the City Attorney's Office, based on the information provided and the follow-up investigation conducted, that complaint is now considered closed.
