

A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA ADOPTING AND CONFIRMING FINAL COSTS ASSOCIATED WITH THE RUBY GRANT WATERLINE PAYBACK PROJECT, A PAYBACK PROJECT OUTLINED IN RESOLUTION R-1920-15 ADOPTED BY THE COUNCIL ON DECEMBER 10, 2019; ACCEPTING THE PUBLIC IMPROVEMENTS CONTAINED HEREIN TOTALING \$97,541; AND AUTHORIZING THE UTILITIES DIRECTOR, OR HIS DESIGNEE, TO RELEASE PROPERTIES AS ASSESSMENTS ARE PAID.

- § 1. WHEREAS, City Council in its meeting of February 11, 1997 adopted Ordinance O-9697-30 for payback of costs to the City from adjacent property owners associated with utility line extensions to provide for the equitable distribution of the costs of said extensions which are more particularly hereinafter described; and
- § 2. WHEREAS, Sections 19-207 through 19-209 of Chapter 19 of the code of the City of Norman, provide for utility line extension and improvement responsibilities; and
- § 3. WHEREAS, City Council in its meeting of December 10, 2019 adopted Resolution R-1920-15 declaring the Ruby Grant Waterline Project as a payback project and authorizing the recovery of costs from property owners benefiting from the project; and
- § 4. WHEREAS, final payback costs for the project have been prepared.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:

- § 5. That a final cost associated with the waterline improvements for the Ruby Grant Waterline Project declared a payback project in Resolution R-1920-15 adopted by the Council in its meeting of December 10, 2019, as more particularly described and defined in Exhibits "A" and "B" attached hereto and made a part thereof.
- § 6. Further, that the Council has delineated the boundaries as shown in Exhibit "A", the map, and the final payback costs of the project as shown in Exhibit "B", the list, prepared and made a part of this declaration, which together show all properties subject to payback, be filed of record in the office of the City Clerk and in the office of the County Clerk of Cleveland County giving notice of this payback project, all pursuant to Sections 19-207 through 19-209 of Chapter 19, of the Code of the City of Norman.

- § 7. Further, that the Director of Utilities, or his designee, be authorized to release and remove from the payback project under the original Resolution R-1920-15 adopted by the Council on December 10, 2019, those properties as their obligations have been fulfilled.
