A RESOLUTION OF THE NORMAN UTILITIES AUTHORITY (THE "AUTHORITY") AGREEING TO **FILE** APPLICATION THE WITH OKLAHOMA WATER RESOURCES BOARD (THE "OWRB") FINANCIAL ASSISTANCE THROUGH THE CLEAN WATER STATE REVOLVING FUND PROGRAM, WITH THE LOAN PROCEEDS BEING FOR THE PURPOSE OF FINANCING STORMWATER SYSTEM IMPROVEMENTS CITY OF NORMAN, OKLAHOMA; **APPROVING** PROFESSIONAL SERVICES AGREEMENT; AND CONTAINING OTHER PROVISIONS RELATED THERETO.

WHEREAS, the Norman Utilities Authority (the "Authority") has under consideration the financing of improvements to the stormwater system serving The City of Norman, Oklahoma (the "City"), including specifically the planting of trees and shrubs, installation of diversion logs, pervious pavement, reinforced vegetation systems and all related appurtenances to stabilize Brookhaven Creek streambank, increase the capacity of downstream creeks and reduce the amount of erosion occurring in the system (the "Project"); and

WHEREAS, it is deemed desirable for the Authority to give preliminary authorization for the issuance of obligations for such purpose; and

WHEREAS, the Oklahoma Water Resources Board has made monies available to qualified entities for the financing or refinancing of certain qualifying projects; and

WHEREAS, the Authority hereby agrees to file an application(s) with the Oklahoma Water Resources Board for financial assistance in the aggregate amount which will be sufficient to accomplish the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE TRUSTEES OF THE NORMAN UTILITIES AUTHORITY, THAT:

<u>Section 1</u>. <u>Application</u>. The Authority shall file an Application(s) with the Oklahoma Water Resources Board seeking financial assistance through the OWRB Clean Water State Revolving Fund Program; and the Chairman or Vice Chairman and Secretary or Assistant Secretary of the Authority are hereby authorized to execute said Application(s) for and on behalf of the Authority. The Authority is further authorized to advance to the Oklahoma Water Resources Board the necessary application fees in connection with the referenced Application(s).

<u>Section 2. Professional Service Agreement.</u> The Chairman or Vice Chairman and Secretary or Assistant Secretary of the Borrower are hereby authorized and directed on behalf of the Borrower to execute a professional services agreement with The Public Finance Law Group PLLC and the Floyd Law Firm, P.C., as Co-Bond Counsel.

<u>Section 3</u>. <u>Other Matters</u>. The Chairman or Vice Chairman and Secretary or Assistant Secretary of the Authority are hereby authorized and directed to do all other lawful things necessary to carry out the terms and conditions of this Resolution.
