SUBJECT: Change Order #6 – Norman Public Library East

City Council Resolution R-1112-55 grants administrative authority to the City Manager to approve change order requests up to \$40,000 or 10% of contract amount, whichever is less, and subsequently report those approvals to the City Council. Attached is a Change Order Summary and quote for a change regarding additional ductwork changes, changes to an access grill to allow for easier maintenance of overhead facilities, paint changes due to door frames and additional metal panels to protect interior wood finishes. This Change Order also provides for a credit of \$2,295.00 for HVAC system stands that were ultimately not needed for this project. Eleven (11) weather delay days are being requested in this Change Order. These days encompass February and March 2018 weather days.

Due to the ongoing Norman Public Library East Project, a change order is being requested by Globe Construction Company in the amount of \$12,747.36. This change order has been reviewed and is being recommended by the project architect, Meyers, Scherer and Rockcastle, Ltd. (MSR), and has been further reviewed by the NORMAN FORWARD program management firm, ADG. An accompanying Memo from both firms is included in the back-up documentation.

The work for this Change Order is being done to provide a credit (\$2,295) for ground stands that were specified in the original bid, but were ultimately not needed due to local climate conditions. Other work included in the this Change Order is for additional metal panels to protect identified wood finishes (\$800), add larger access panels for maintenance crew access (\$389.09), corrections needed for mechanical ductwork for HVAC systems (\$10,654.87) and work needed to revise paint on interior door frames (\$3,198.40).

We have reviewed the change order with both MSR and ADG to confirm that the items listed therein are acceptable. At this time, we recommend approval of the change order from Globe Construction Company in the amount of \$12,746.36. Funding is available in account number 51-9507-455.6101 - Project NFB 017.

Architecture Interiors and Urban Design

The descriptions below are intended to explain the reasons for each change stated in CO #006, and the associated costs for each change. Reference CO #006 for the formalized and signed document outlining these changes. Reference the potential change orders produced by Globe Construction for the origination of stated costs.

PCO 019 - Mechanical Ductwork - \$10,654.87

Explanation: This change order addresses the issue that ductwork throughout the main public room of the library conflicts with the ceiling plane that slopes up to the head of the curtain wall along the exterior edge of the building. No RFI was issued with this conflict and a note on the mechanical drawings was not correctly written which confused the fact that these ducts needed to be placed between the joists. This is necessary to get the ductwork in the correct location and provide a clean interior finish. MSR recommended.

PCO 021 - F-Reveal Fry Reglet - \$800.00

Explanation: This change order provides a F-reveal fry reglet (black) at the bottom of the WD-02 to ensure a uniform termination. This will ensure our detail is seamless at the head of the interior passageways, and it will protect the underside of the wood finish strips. MSR Recommended.

PCO 022 - Paint Door Frames - \$3,198.40

Explanation: This change order addresses the issue that door frames needed to be painted black per the contract documents, but the note on the Finish Plans was overlooked by the contractor and architect reviewing the question raised. The direction given was to paint the frames white. Once the mistake was realized, the design team requested that the frames be painted black. To realize this change, the subcontractor had to take extra time to prep the frames and provide black paint. The black will add value with longevity and maintenance concerns in mind. MSR recommended.

PCO 023 - Carpool Parking - \$0.00

Explanation: Adding lettering in parking stalls for car pool parking designations at no cost. MSR recommended.

PCO 024 - FCU Return Grille - \$389.09

Explanation: Per conversations with the owner, concern was raised about ease of access for maintenance to the return grille in Vending 104. It shall be changed to a 24x24 return grille with filter frame (Price 530FF or engineer approved equal) in powder coat white. 2" MERV 13 filter shall be installed in filter frame. MSR takes no exception.

PCO 027 - HP Stands - (-\$2,295.00) credit

Explanation: This provides a credit back to the project to eliminate the HP unit steel stands from the scope of work. See RFI 122 for design team full explanation of the issue. MSR takes no exception.
