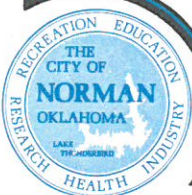


A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, APPROPRIATING \$234,494 FROM THE PARK LAND FUND BALANCE FOR IMPROVEMENTS TO BE USED FOR IMPROVEMENTS TO THIRTEEN (13) PARKS IN THE CITY OF NORMAN.

- § 1. WHEREAS, on March 1, 2011, voters in Norman approved a City Charter amendment providing for the expenditure of fees-in-lieu of park land that were collected between 1976 and 1994 for the purpose of making park improvements in areas where suitable land is not available to purchase; and
- § 2. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to add pedestrian lights along Brookhaven Boulevard and at the parking lot; repair, resurface, and re-stripe the parking lot; rebuild the baseball backstops and upgrade all of the park furniture in Brookhaven Park; and
- § 3. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to add a walking trail, trees, and a park sign at Brookhaven Square Park and to add new soccer goals with nets, new park furniture, and a new park sign at Castlerock Park, and
- § 4. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to add a new park sign and replace the half-court basketball court with a full-size court at Cherry Creek Park and to improve the park sidewalks and street-side drainage at the park entry at the dead-end of Stonewell Drive; and
- § 5. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to plant more trees at Deerfield Park; add new site furniture and a new park sign at Faculty Heights Park; and upgrade the park furniture and install new landscaping at Ruth Updegraff Park; and
- § 6. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to remove the pipe rail fence along the street, add a new park sign and pave the gravel walking trail in the park at Lion's Memorial Park and to add a new park sign and replace aging play equipment at Normandy Park; and
- § 7. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to pave the trail, upgrade the site furniture and add a new park sign in Oaktree South Park and to construct a perimeter walking trail, add a new park sign and renovate the baseball backstop at Tull's Park, and
- § 8. WHEREAS, Staff is recommending an appropriation from the Park Land Fund Balance to add a new park sign at Walnut Ridge Park and construct a concrete path from Castlewood Drive across the park over to the playground area and purchase site furniture for Willowbend Park to be stored until the park is developed; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:
