

**AMENDMENT NO. 1 TO CONTRACT NO. K-1415-16
CONSULTANT SERVICES AGREEMENT**

This Amendment No. 1 to Contract No K-1415-16 is made and entered into as of December 8, 2015, by and between the City of Norman, Oklahoma ("City") and Black & Veatch Corporation, a successor in interest to RCC Consultants, Inc. ("CONSULTANT"), collectively the "Parties".

WITNESSETH:

WHEREAS, Contract No. K-1415-16 between the Parties was entered into on August 12, 2014 for the purpose of providing consultant services for Phase 1 of the replacement of the City's Emergency Communication System; and

WHEREAS, Phase 1 included a needs assessment, development of system alternatives, and preparation of budgetary cost estimates for the City replacement of the existing Emergency Community System; and

WHEREAS, during the completion of Phase 1, the City and RCC identified the need to conduct a partnership meeting with current and potential partner agencies to inform them of the project and begin discussions about possible partnerships;

WHEREAS, the partnership meeting was not included in the scope of the original agreement;

WHEREAS, RCC Consultants filed for bankruptcy during the Summer of 2015 and was acquired in bankruptcy proceedings by CONSULTANT.

NOW, THEREFORE, in consideration of the mutual promises contained herein and in Contract No. K-1415-16, the parties agree to the following amendments:

ARTICLE I – Scope of Work

The scope of work is hereby amended to include the facilitation of a partnership meeting between the City and representatives of public safety and government agencies from the State, County and local area.

ARTICLE II – Fees and Expenses

The fees and expenses are hereby amended to include an additional \$2,550.86 for the facilitation of the partnership meeting with public safety and government agencies described herein.

ARTICLE XII(F). Successors and Assigns. CITY recognizes CONSULTANT as a successor in interest to this contract pursuant to the Order Authorizing and Approving Assumption and Assignment of Certain Executory Contracts filed in *In re: RCC Consultants, Inc.*, Case No. 15-18274 in the United States Bankruptcy Court, District of New Jersey.

All other provisions of Contract No. K-1415-16 shall apply as if fully set forth herein.
