HD (19-8) Consideration of the Certificate of Appropriateness request for the replacement of original wood windows with vinyl windows for property located at 904 Miller Avenue.

Background:

Historical Information:

2004 Miller Historic District Nomination Survey Information:

Ca. 1925. Colonial Revival. This contributing, two-story, vinyl-sided, single dwelling has a brick foundation and an asphalt-covered, clipped, side-gabled roof. The wood windows are vertical, five-over-one, hung and the wood door is slab with half sidelights. The entry porch is presently uncovered. Other exterior features include an interior, red brick, ridge chimney and a one-story extension on the south side. Decorative details include double windows and gable returns.

Sanborn Map Information:

The principal structure is shown in the same location and configuration as present day.

Property History:

There have not been any COA requests made for this property.

Project Information:

On June 25, 2019, staff received an email from a concerned resident that the house located at 904 Miller Avenue had replaced all of the windows in the structure with vinyl windows. Staff immediately visited the property and observed that a window contractor was in the process of finishing the replacement of all of the original wood windows in the house with vinyl windows.

The property owner, Theckla Mendros, arrived at the property shortly thereafter and stated to staff that she was not aware of being in a Historic District. Additionally, Mrs. Mendros invited staff to view the condition of the removed wood windows which she had stored in the rear of the house. Upon examination, staff informed the applicant that the windows were repairable and urged the applicant to keep the windows as possibly they could be re-installed.

Since that time, staff has worked with the son, Jorge Mendros, regarding the window replacement and the COA process. Staff informed Jorge Mendros as well, that the original windows should be retained in case re-installation of the windows was needed. Staff sent via email to Jorge Mendros a list of wood window contractors that could be contacted regarding re-installation of the original wood windows.

As can be seen from the pictures contained in the agenda packet, all the windows in the house have been replaced with vinyl windows.

Ordinances & Guidelines:

Preservation Guidelines

3.5 Guidelines for Windows and Doors:

.1 Retain Original Windows. *Retain and preserve original windows, including glass, frames, sash, muntins, sills, heads, moldings, surrounds, and hardware.*

.2 Retain Historic Glass. *Retain original glass in historic windows if at all possible. Leaded glass windows shall be preserved. Bubbles and waves give old glass its distinctive look and add to the historic character of the house.*

.3 Preserve Original Doors. *Retain and preserve original doors and door surrounds including frames, glazing, panels, sidelights, fanlights, surrounds, thresholds, and hardware.*

.4 Replace Only Deteriorated Features. *If replacement of a deteriorated window or door feature or details is necessary, replace only the deteriorated feature in kind rather than the entire unit. Broken sash cords, for example, can be repaired and do not necessitate replacing an entire window. Match the original in design, dimension, placement, and material.*

.5 Replacement Doors. *Replacement doors and door surrounds shall be appropriate to the style of the structure. Doors shall be relocated, enlarged, or introduced only when the alteration is appropriate to the style of the building.*

.6 Storm/Screen Doors. *Wood framed screen doors and full-light storm doors do not require a COA or Administrative Bypass.*

.7 Window Replacement by Administrative Bypass. *A deteriorated window may be replaced "like with like," based on the following criteria:*

Typically all wood construction

*Muntin width and profile are very similar to the original in
width and profile*

Light pattern is the same as the original

*True divided lights (window panes) are the same as the
original*

Size and dimension of all window components are the same

as the original

.8 Window Replacement by COA. *A deteriorated window replacement, other than “like with like” as defined above requires a COA and shall conform to the following:*

Shall have a wood exterior, unless replacing a metal casement window

Aluminum or vinyl cladding is not appropriate

Light patterns same as the original

Size and dimension the same as the original

Double-pane simulated divided lights with wood muntins on the exterior and interior and a shadow bar between the panes may be allowed for windows on the side or rear that are not visible from the street

.9 Retain Original Metal Windows. *Replace original metal casement windows only as a last resort after weatherization measures have proven unsuccessful.*

.10 Preserve Original Openings. *Do not create new openings in the front or side facades of historic structures. Do not enlarge or diminish existing openings to fit stock window and door sizes. If new openings are necessary to meet code requirements, they shall be compatible with historic windows for that structure in proportion, shape, location, pattern, size, materials, and details.*

.11 Locate Privacy Glass in Rear. *Privacy glass may be installed where required in divided light windows (such as in a bathroom) but only located in the rear 50% of the structure. Smoked or tinted glass is not appropriate for use in historic structures.*

.12 Use Wood Windows in Primary Structures and Additions. *For construction of new primary structures, choose windows that complement window types in surrounding structures in material, placement, size, shape, and design. While single-pane, true divided-light, wood frame windows are the most desirable choice for new construction in historic districts, double-pane glass wood windows with interior and exterior applied muntins and shadow bars between the panes are permitted. Aluminum cladding of wooden windows is permissible for use in construction of new primary structures and additions. Vinyl cladding of wood windows is not appropriate.*

.13 Install Awnings Carefully. *Fabric window awnings that conform to material, style, shape, and location may be approved by Administrative Bypass. Install fabric awnings over windows, doors, storefronts, or porch openings with care to ensure that historic features are not damaged or obscured.*

Staff Comments

As indicated above, this is *ex post facto* review of window replacement, which the Historic District Ordinance requires the Commission to review the case as if the work has not occurred. Staff would note that this house is a contributing structure to the Miller Historic District. Since this house is located on a corner and faces two streets the property is considered to have two facades as defined by the Historic Preservation Guidelines.

Pictures obtained from the 1988 Miller Historic District Survey, the listing from a real estate website, and Google Earth show wood windows throughout the house prior to the installation of vinyl windows. The window pane configuration was 5-over-1, though there were also 1-over-1, 4-over-1, 6-over-1 pane configurations as well.

The Historic Preservation Guidelines clearly state in Sections 3.5.1, 3.5.2, and 3.5.4 the requirement to preserve original wood windows.

The Commission has consistently required the preservation of original wood windows since the establishment of the both the Chautauqua and Miller Historic Districts in 1995 and 1997 respectively. There have been three cases of note reviewed by the Historic District Commission in the past decade regarding replacement of original wood windows:

327 Alameda Avenue

This case was an *ex post facto* request for the replacement of the all original wood windows in entire house with vinyl windows. Request for replacement of the original wood windows denied by the Historic District Commission. The applicant appealed the denial to City Council which upheld the Commission's decision. However, the applicant was allowed three years to install wood windows. Wood windows were reinstalled by the three year deadline.

321 Duffy Street

This case was an *ex post facto* request for the replacement of some of the original wood windows with vinyl windows. The request for replacement of the original wood windows was denied by the Historic District Commission. The applicant appealed to City Council, however, the applicant withdrew the appeal and re-installed wood windows.

549 S Lahoma Avenue

This case was an *ex post facto* request for the replacement of some of the original wood windows with vinyl windows. The request for replacement of the original wood windows was denied by the Historic District Commission. The applicant appealed the denial to City Council which upheld the Commission's decision. The applicant filed suit in Cleveland County District Court and court proceedings have been ongoing since. As of writing of this report, the case has been reversed and remanded back to District Court and further litigation is still pending.

The property owner has indicated that they were unaware that they were located in a Historic District. While it is the responsibility of property owners to be aware of City codes and regulations affecting their property, staff did research the notification process for the designation of the Miller Historic District in 1997. Staff has attached the letter and the list of property owners and mailing addresses used to send notification letters during the Historic District designation process in 1997. This indicates that the property owners were sent a letter in 1997 notifying them of the rezoning request to designate their property to Historic District.

Additionally, it should be noted that staff contacted the real estate agent for this property after a sign was placed in this last year indicating it was for sale. Staff has attached a PDF of an email on November 15, 2018 to the real estate agent, Taylor Davis, informing him that the property was located in the Miller Historic District.

Finally, as part of the Certified Local Government Grant Projects, in May of this year, a letter was mailed to every property owner in Norman's three Historic Districts, reminding them that their property is located in a Historic District and that there are additional regulations to follow. I have attached the letter and a list of property owners sent this letter.

This request does not meet the Historic Preservation Guidelines which require the preservation of the original wood windows, therefore, staff recommends that Historic District Commission deny this request to replace the original wood windows with vinyl windows.

Commission Action:

Approve or deny the request to replace the original wood windows with vinyl windows for the property located at 904 Miller Avenue.

The purpose of this letter is to formally provide you with *Legal Notice* that the **Miller Avenue Neighborhood Association** has submitted a request to the City of Norman for **Historic District Designation** for property generally located between **Symmes Street on the north, Macy Street on the south, Classen Boulevard on the east and one-half block west of Miller Avenue on the west**. You, as the owner of property within the area being proposed for Historic District Designation, are being notified by mail so that you may have the opportunity, if you so desire, to express yourself as to whether or not this request should be approved. The Historic District Commission will consider the request at its meeting of **November 3, 1997, at 7:00 p.m. in the Multi-Purpose (Lowry Room) of the Norman Public Library located at 225 North Webster Avenue**; and, if a recommendation is made, their recommendation will be forwarded to the Planning Commission which will conduct a Public Hearing on this request tentatively scheduled for **November 13, 1997, at 7:00 p.m. in the Multi-Purpose (Lowry) Room of the Norman Public Library**. If the Historic District Commission does not vote on a recommended Historic District boundary at their meeting on November 3, 1997, the proposed action will not be forwarded to the Planning Commission until such time as a recommendation is made. At that meeting, the public is invited to appear and protest or support this request. Any protest must be in writing and filed with the City Clerk **prior to 5:00 p.m. on October 29, 1997, in order to be reported to the Historic District Commission; and, by 5:00 p.m. November 10, 1997, in order to be reported to the Planning Commission**. Any protests received after that deadline will be reported to the City Council. Should the request for Historic District Designation be approved, controls will be placed on any new construction, demolition of structures, or exterior remodeling of structures within the district. The property owned by you which is included in the request for Historic District Designation is described as follows:



Dear Historic District Property Owner,

This letter is a friendly reminder to all property owners in the Chautauqua, Miller and Southridge Historic Districts, of the Historic Preservation regulations that are in place for your property. In 1993, the City Council adopted a Historic District Ordinance (O-9293-30) which enabled the establishment of historic districts in Norman. At the request of the property owners in three neighborhoods, the Chautauqua Historic District was founded in 1995, the Miller Historic District followed in 1997 and more recently the Southridge Historic District in 2016. In the summer of 2018, both the Chautauqua and the Southridge Historic District were expanded to include additionally properties. A historic district designation overlay imposes additional zoning requirements in these three districts.

The purpose of the formation of the Chautauqua, Miller and Southridge Historic Districts is to manage changes to historic properties in a way that preserves an individual building's historic character and protect the historic integrity of the district as a whole in a manner that is fair and consistent. This goal is achieved by requiring that exterior alterations proposed to properties in the historic district be reviewed by the City's Historic District Commission.

The Commission uses the set of historic guidelines contained in the *Norman Historic Preservation Handbook* as the basis for reviewing proposed exterior work. The Commission and staff have worked with over 150 applicants during the past 20 years, to approve a vast majority of exterior alterations proposed by property owners. If you as a property owner do not have a copy of the Historic Preservation Handbook you may download a copy from the City's website at: <http://www.normanok.gov/planning/historic-preservation>. If you would prefer a hard copy of the *Historic Preservation Handbook* please contact me and I will make sure you receive a copy.

As a property owner in a designated historic district, I would like to inform you of an historic home educational opportunity and to remind you of the regulations regarding historic districts in Norman. I would like to let you know that the City's Historic District Commission with funding through the state Certified Local Government Program, is able to offer educational workshops and seminars. The City will hold a **Wood Window Restoration Workshop June 1, 2019**. Please see attached information sheet for further information regarding this workshop.

For your quick reference please find enclosed a Frequently Asked Questions Fact Sheet regarding Norman's Historic District Ordinance that may answer many of your basic questions. As the City's Historic Preservation Officer, I'm here to assist you with any issues that may arise regarding the historic districts and I am available to meet with you on site as well.
