

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NORMAN,
OKLAHOMA, AMENDING SECTION 20-1002 OF CHAPTER 20 OF
THE CODE OF THE CITY OF NORMAN TO ALLOW THE DIRECTOR
OF PUBLIC WORKS TO ESTABLISH SPEED LIMITS IN
CONSTRUCTION ZONES; AND PROVIDING FOR THE
SEVERABILITY THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORMAN,
OKLAHOMA:

§1. That Section 20-1002 of Chapter 14 of the Code of the City of Norman, Oklahoma, shall
be amended to read as follows:

* * * * *

(a) Except as otherwise provided in this chapter, no person shall drive any vehicle at
speeds greater than the following upon the following highways, roads, streets, or portions
thereof:

- (1) On all alleys unless otherwise posted15 mph
- (2) On all streets where school zones and school
crossing zones are designated, on days when
school is in session, between the hours of
8:00 a.m. and 5.00 p.m., unless otherwise posted20 mph
- (3) On all streets excerpt those specifically listed
in section 20-1002 and upon all streets adjacent
to schools at times others than specified in item (2)25 mph
- (4) On all section line roads except those specifically
listed in section 20-1002.....50 mph
- (5) On all federal and state highways, except those portions within the city limits
specifically listed below, the state traffic speed regulations shall apply.

(b) Specific speed limits not otherwise designated shall be set by the Director of Public
Works or his designee based on pertinent traffic data obtained through traffic engineering
studies. Three (3) copies of those specific speed limits shall be kept on file at the Office
of Public Works and the City Clerk's Office at all times.

(c) Where any city, state, or federal road or highway shall be under construction,
maintenance, or repair or when a detour shall have been designated by reason of
construction, maintenance, or repairs in progress, the Director of Public Works, or his

designee, may establish a maximum safe, careful, and prudent speed on the basis of engineering and traffic investigation for said construction zone. No person shall drive any vehicle upon the portion of the road, highway, or detour at a speed in excess of the speed so determined and posted. For purposes of this section, "repair, maintenance, or construction zone" means any location where repair, maintenance or construction work is actually in progress and workers present.

§2. **Severability.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is, for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this ordinance.
