ORDER FOR PARTIAL DISTRIBUTION
58 O.S. §§ 621, 622, 624

NOW on this 18th day of December, 2017, there comes on for hearing before this Court the Petition for Partial Distribution of the Personal Representative, Martha Henderson, of the Estate of James Stephen Freeman, Deceased.

The Court having reviewed the pleadings filed herein and having heard the statements of counsel, and having examined the evidence, finds as follows:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT:

1. Notice of hearing on this Petition has been given to all heirs at law, devisees, and legatees of the Freeman estate pursuant to 58 O.S. § 622. An Affidavit of Mailing Notice appears on file herein.
2. No objections to the granting of this Order for Partial Distribution have been raised.
3. Over three months have passed from the date the Court issued its Letters of Administration to said Personal Representative and said letters appear on file herein.
4. That pursuant to the information set forth in said Petition for Partial Distribution by the Personal Representative, the estate will have much less tax liability under the circumstances.
5. All valid debts known by the Personal Representative and the necessary estate expenses of administration, funeral and last illness of said Decedent as set forth in the Petition have been fully paid or otherwise provided for and the estate is but little indebted.
6. That the circumstances are such that no bond is necessary and a bond should not be required pursuant to 58 O.S. § 624.
7. That after said Partial Distribution, the estate will still have ample money set aside to cover any final estate expenses and costs remaining before final distribution at a later date.




