A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, APPROPRIATING \$187,418 FROM THE NEIGHBORHOOD PARK LAND FUND BALANCE FOR IMPROVEMENTS TO ADKINS' CROSSING, COLONIAL ESTATES, COLONIAL COMMONS, AND SUNRISE PARKS.

- § 1. WHEREAS, on March 1, 2011, voters in Norman approved a City Charter amendment providing for the expenditure of fees-in-lieu of park land that were collected between 1976 and 1994 for the purpose of making park improvements in areas where suitable land is not available to purchase; and
- § 2. WHEREAS, Monroe Park was the first project to be constructed with fees-in-lieu of park land and recently Staff identified four parks with funding available for improvements; and
- § 3. WHEREAS, improvements at Adkins' Crossing Park will include replacements of picnic tables, trash cans, benches, swing sets, and soccer goals; adding a backstop; and repairing and restriping the parking area along 24th Avenue S.W.; and
- § 4. WHEREAS, Colonial Estates Park will have damaged segments of the walking trail replaced and areas of narrow trail widened; pedestrian bridges replaced or repaired; disc golf baskets and concrete tee pads replaced; and curb-side sidewalk gaps filled in along Beaumont Drive; and
- § 5. WHEREAS, Sunrise Park will have the backstop and concrete entry ramp from the street into the park replaced; sidewalks added along Skyline Drive and across the park from Skyline to the apartments north of the park; soccer goals with nets added; and the sand volleyball standards and net will be repaired.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:
