**BACKGROUND**: In January 2013, the Office of Emergency Management applied for and was approved to receive a grant from the Oklahoma Office of Homeland Security to support the Norman Citizen CORPS volunteer programs. The Grant awarded was for \$10,992.13 and City Council accepted the grant on April 9, 2013.

**DISCUSSION**: In September 2013, the Office of Homeland Security announced another grant opportunity and Emergency Management was approved for additional funding in the amount of \$29,742.88, increasing the

original amount of the grant to \$40,735.01. The grant allows for the purchase of a portable shelter with environmental unit used for field training, remote lighting capability, various outreach material for community events, a portable display unit, various manikins used for training. In addition it provides for canopies, fire extinguishers for a trailer, audiovisual equipment and tables to support activities.

**<u>RECOMMENDATION</u>**: It is recommended that City Council accept the additional funds in the amount of \$29,742.88 under the FYE 2010 Homeland Security Grant Program; receipt into Other Revenue: Emergency Management Grant (022-0000-331.13-60) and appropriate funds as follows.
