Subject lots include existing sanitary sewer, sewer force main, and public water lines located in multiple existing Utility Easements (U/E's). However, the applicant apparently only desires to close three (3) small U/E's on the property. The primary function of each of these three (3) U/E's is to provide a short 6-inch water line terminating at a fire hydrant, for protection of the property.

NUA staff has reviewed the request to close the U/E's. Presumably the owner/applicant will provide adequate fire protection coverage for future development on each and all of the three (3) lots. Such coverage will be a part of the approval of future development of the lots. Therefore, NUA staff does not object to the requested closing.-Please advise if you have any questions.
