MISCELLANEOUS DISCUSSION

<u>Election Discussion</u>. Ms. Cindy Rogers, 633 Reed Avenue, said she appreciated the discussion about the General Obligation Bonds coming forward instead of sales tax. She was glad that Homelessness is being considered as part of the quality of life initiative. She believes setting aside money and then determining how to use it in the best way possible is completely appropriate. She is in favor of voting on the municipal bonds in June and then voting on NORMAN FORWARD when those needs are addressed. She also voiced concerns about the 60% increase of the bond issue when the economy is looking pretty rocky.

Councilmember Hall said Council and Staff had exchanged a lot of information during all of these meetings. She said Council is trying to get it right and do what is best for the City going forward. She appreciates everyone putting in all the time and taking the extra effort. She stressed the importance of feedback from the public. She respects where all of her colleagues are coming from. She is confident they will be able to find a way to fund all of these important projects and maybe address some of the projects, such as stormwater, that need funding.

Mayor Pro Tem Holman said the discussion will continue on Tuesday, March 17th.

*

<u>Conservation</u>. Mr. Evan Dunn, 1400 Garfield Avenue, said people need to understand the seriousness of what is happening in the oil industry and how it affects the economy. He has been talking about oil conservation and the way we squander it. He said he had been talking about local food production for more than 10 years. He said rural Oklahoma grows their own food and lives off of the land. He said this country needs someone like Kennedy who is committed.

*

<u>Item 18, Park Playground Budget</u>. Mr. Anthony Francisco, Director of Finance, said he had information to answer Councilmember Petrone's question regarding the account that can utilized for park playground improvements. He said the Park Playground Maintenance fund is in the Capital Fund Balance. He said the original budget was \$15,000 and after tonight's appropriation, a balance of \$9,969.01 remains.

*

Mary Church Terrell. Councilmember Bierman said Mary Church Terrell was born in 1863 to former slaves in Memphis, Tennessee, and began her activism at age 29 when a friend of hers was lynched by white business owners. She said Mary joined Ida B. Wells in anti-lynching campaigns for the next several years; but it was her belief that a critical component to ending racial discrimination was by black people advancing themselves through education, work, and community activism. She said in 1896, Mary was one of the founders of the National Association of Colored Women with the motto "Lifting as we climb". As president, she actively embraced and championed women's suffrage because she knew she belonged "to the only group in this country that has two huge obstacles to overcome, sex and race." She was a founding member of the National Association for the Advancement of Colored People (NAACP) and founder of the National Association of University Women. She continued to fight for integration in the Washington D.C. area and targeted restaurants through boycotts, pickets, and sit-ins and when she was refused service, she sued them and that eventually led to a ruling that ended segregated eating places in Washington D.C. in 1953. She lived long enough to see the Supreme Court deem "separate but equal" unconstitutional and died two months later at the age of 90.

Miscellaneous Discussion, continued:

<u>Coronavirus</u>. Councilmember Carter said he sees the Coronavirus in animals, particularly cattle, and veterinarians have a Coronavirus vaccine for cattle. He anticipates there being a vaccine for humans soon. He stressed the importance of handwashing and not contaminating inanimate objects. He hoped there would not be an outbreak in our region like some other countries. He said it has a devastating effect on retail business and sales tax revenue.

Councilmember Petrone read a statement from an Intensive Care Unit physician in Italy where the Coronavirus has filled up all of the hospitals. She said the cases have overwhelmed the doctors and hospitals with 15-20 cases coming in per day with many being too far gone to treat. The hospitals had no beds left and the staff was exhausted and becoming ill as well. The medical staff are unable to see their families for fear of infecting them.

*

<u>Fire Chief Visits Truman Primary</u>. Councilmember Petrone thanked Mr. Travis King, Fire Chief, for visiting Truman Primary and talking to the kids about personal hygiene and fire safety.

*

<u>Thanks to City Staff</u>. Councilmember Hall thanked City Staff for providing a significant amount of information and answering lots of questions. She said City Council is trying to do what is best for the City and she really appreciates all of them taking the time and extra effort to provide the information to Council.

*

Sooner Theatre. Councilmember Hall said she had accompanied her granddaughter to Sooner Theater for her first play on Sunday, March 8th, which was the Little Mermaid. She said her guest from out of town also attended and were astonished that the cast was made up of middle school and high school students from Norman and not real actors. She said the production and the costumes made it a magical experience and she was proud of all of the different organizations in Norman that work so hard to contribute to our quality of life.

*

<u>Prescribed Burn in Ward 5</u>. Councilmember Wilson said she had talked with Mr. Travis King, Fire Chief, about a prescribed burn that might be scheduled by Forestry Department. She said Chief King told her that if conditions seemed right over the next week or so, it would happen, and urged her constituents to be aware of this if smoke is seen west of the Lake Thunderbird area.

*

Councilmember Scanlon's Aunt. Councilmember said his aunt grew up in the 1920's and became a school teacher because that was what women did in those days. He said she later got a private pilot's license and flew an open cockpit biplane while backpacking through Europe and South America in the 1930's. When World War II started, she enlisted because her brothers did and was chosen for the first officer training class for women and being 5-feet tall, was the shortest person in the class. She led the first contingent of women, other than nurses, overseas and worked for General Eisenhower planning the D-Day Invasion. She went on to become the director of Women's Army Corps and held that job for six years until women were totally integrated into the Army. He said she held the rank of Colonel and he was honored to wear her insignia. He said when she was asked what her secret to success was, she said "you do your thing and remember that you do not have to be six feet tall and a man to have a brain."

Miscellaneous Discussion, continued:

<u>Water Reclamation Facility</u>. Councilmember Scanlon said the City received a grant for water reuse which goes through the Water Reclamation Facility to be put back into Lake Thunderbird. He said he was told there was equipment already in place at the Water Reclamation Facility. He said everyone that works at the Water Reclamation Facility keeps track of the progress and has a stake in the success. He said by switching out certain switching units to be more efficient, the City saves approximately \$10,000 per month in utility bills.

Mayor Pro Tem Holman encouraged all citizens to visit the Water Reclamation Facility. He said this facility is tied with the Water Treatment Plant for importance to the city. He said there are tours of this facility and it is worth it to see how it works. He said many tax dollars voted on by the citizens have gone into this facility.

*

<u>Water Reuse</u>. Councilmember Scanlon said there was an Expo last week staged by our Utilities Division and it was a Texas and Oklahoma combined event. He learned that by the simple substitution of a certain type of trailer at the Transfer Station, the City saves \$100,000 per year in processing costs. He complimented the Utilities Department.
