Election Today. Councilmember Williams thanked everyone who voted today, the turnout was not as good as he would have liked.

Commending the Police Department. Councilmember Williams said the Police Department had been very busy on Monday, February 11th in Norman. He said there had been a traffic accident with a fatality, fugitives that were captured, and a bank robbery. He said he had the opportunity to hear most of what transpired and was thrilled at how well the situations were handled in a such timely fashion. He said he received several telephone calls about the traffic that had been diverted off of Interstate 35 during the traffic accident which had really affected Ward 8, but assured them the City responded to the situation in a timely fashion. He thanked the Police Chief and all other departments for their efforts. He said to see them work so well with other agencies was impressive.

Councilmember Lockett said she was going to a meeting during all of the activity and had been stopped by the roadblock. She said she was impressed with their professionalism of our Police Department. She said Governor Fallin released the Top 20 Sharpshooters Report for the State of Oklahoma and eight were from Norman and she congratulated them.

Councilmember Castleberry said he was at Whittier Middle School yesterday trying to get inside when the schools were locked down. He said he could not get in and was not allowed to leave the parking lot. He said he was very impressed with the coordination between the Police Department and other law enforcement agencies. He had asked the Police Chief if the Police Department had all the resources needed to handle the situation and was assured that they did. He is proud this city is invested in the Fire and Police Departments and that Norman is a very safe place to live. He thanked the Police Chief for a job well done.

Councilmember Kovach joined his colleagues in expressing his appreciation of the Police Department. He said he was on Interstate 35 for an hour and half while it was shut down. He said the number of officers involved in diverting people off of the interstate and getting everyone through to the right intersection required a lot of coordination.

Legacy Trail Extension. The Oklahoma Department of Transportation had just given approval to start the bidding process for the southern link to the Legacy Trail Extension. This section will be from Duffy Street to Boyd Street and will include a four-foot sidewalk and some driveway approaches. There will be a ten-foot portion of Legacy Trail on Duffy Street from Jenkins Avenue to Asp Avenue. This extension will effectively provide the connection to the University. Going north, the Legacy Trail will eventually connect at Tecumseh Road and travel up 36th Avenue N.W. to Ruby Grant Park.
