#### MISCELLANEOUS DISCUSSION

Water Rate Questions. Mayor Rosenthal said a question was submitted about the proposed water rate increase asking whether or not some issues brought up at the public meeting last week would get further consideration by Council. On October 21st, there will be a Study Session to discuss the water rate increase and citizen feedback will be discussed at that time as well as discussion and direction to staff with respect to the connection fee.

Ms. Mary Francis, 850C Cardinal Creek Condos, also asked what the average residential customer's demand during the summer months and how is it calculated? Mayor Rosenthal said she would ask Staff to answer her questions.

Councilmember Jungman said Ms. Francis' questions were good ones. He said the experts called it an equivalent residential connection and that this is not information that had been given out. He said he hoped to get this information to look at it as we move forward.

Councilmember Miller said this is a critical issue for our City. She said the City had worked two years on a Strategic Water Supply Plan. She said staff has given Council a lot of information and there are required upgrades and more well capacity needed. She said this is the citizens' rate increase to obtain good, quality drinking water. She said she hoped everyone would come to the Study Session and asked questions. She said people needed to get out and vote as well.

Councilmember Heiple there had been a healthy debate about the rate increase and the building community and citizens have worked on a solution.

\*

Oil Well Issues. Ms. Cindy Rogers, 633 Reed Avenue, brought photographs to Council regarding an oil well site that was leaking and said she would like to have some updated information. She suggested a citizens' oversight committee be established to investigate and consider the process of well site supervision. She said this committee could set up an inspection process to give citizens more security that well sites are being adequately monitored. She said it was her understanding that there is one inspector and several wells and they are not inspected very often, maybe once or twice a year depending on the status of the wells.

Mayor Rosenthal asked the City Manager to respond regarding an update about the leaking well. Mr. Steve Lewis, City Manager, asked Ms. Susan Connors, Director of Planning and Community Development, to provide a report because she had visited the site. She said she visited the oil well site for Todd No. One and Todd No. Two, which are located on the north side of Highway 9 on 72nd Avenue N.E. She said Todd No. One was drilled in 1985 and Todd No. Two in 1991. She said on the Todd No. One site there is a pump jack which is not operational because the motor was stolen, but there is a tank site that is bermed appropriately as required by City Code. She said there was rain water in the berm area and no evidence of any oil spill anywhere on the site. She said there are areas where the earth is darker but no violations exists. She said Todd No. Two is just a pump jack which is operational and pumping oil into the tanks. No violation exists. She said the pumper came and met City staff at the site and at that time, she showed him a few empty plastic jugs that needed to be removed and there was some piping that could be moved. Ms. Connors said both of these sites were gated and locked. She said there are "No Trespassing" signs on the sites as well.

Councilmember Holman asked when there is oily residue on the ground and it rains, does the water seep into the ground. Ms. Connors said it either evaporates or seeps into the ground. She said the berm around the tanks is the protection for any leakage or spills that would contain the water around the tank.

Councilmember Jungman said it was his understanding that the berm has to be a certain size or volume to contain the spill. He asked if the City evaluates the volume of the berm. Ms. Connors said the Oil and Gas Inspector would be visiting the site in the next few days and he would calculate that. She said it is calculated on the amount of oil contained in the largest tank on the site so it is not a specific height required by the Code and can be varying heights and sizes. Councilmember Jungman asked when the City determines if the berm is the right size. Ms. Connors said that is done when the tanks are placed.

Miscellaneous Discussion, continued:

Oil Well Issues, continued. Councilmember Castleberry asked how many active wells there were in the City of Norman and Ms. Connors said there were 165. Councilmember Castleberry asked if they had annual inspections with one inspector and Ms. Connors said yes. Councilmember Castleberry said five days a week, 52 weeks a year equals 260 days which means the inspector can inspect at least one well a day. Ms. Connors said it is much easier to inspect wells on the west side of the City while those on the east side were much more remote. Councilmember Castleberry asked if it took a whole day to inspect one well and Ms. Connors said no. Ms. Connors said the inspector does inspect the wells more than once a year and right now there is a drilling operation going on so the inspector is at that site every day. Councilmember Castleberry asked Ms. Connors if she thought this was adequate staffing and she said it was adequate and there had never been a complaint from the oil well operators and only minor spills within the last 15 years.

Councilmember Jungman asked what an inspection entailed. Ms. Connors said there is a checklist. Councilmember Jungman asked if these were open records. She said yes.

Councilmember Miller thanked Staff for visiting the site today because it is a concern and important to make sure everyone is safe. She said the City Council Oversight Committee is looking at the Oil and Gas ordinance at this time, particularly as it relates to oil well safety in the watershed area.

Mr. Steve Lewis, City Manager, said the Oversight Committee had made recommendations to Council and Council had deliberated on some of the amendments. He said on October 28th, an ordinance would be coming forward on First Reading with Second Reading on November 10th. He said these amendments have to do with fencing regulations, landscaping requirements and maintenance responsibilities.

40 Days For Life. Councilmember Lang complimented the participants of the 40 Days for Life for their peaceful observances during the process which is at the halfway point.

<u>Crop Walk for Hunger</u> Councilmember Holman encouraged people to become involved in the Crop Walk on Sunday, October 19th, by either walking or donating to the cause.

Mayor Rosenthal said this is a great event and does a lot in our community to help stop hunger and to give assistance to Food and Shelter and other agencies.

National Night Out. Councilmember Holman thanked everyone who participated in National Night Out on Tuesday, October 7th. He said he hoped to see a lot more neighborhoods in his ward next year and that Cobblestone Creek neighborhood did a great job.

Councilmember Castleberry thanked the organizers of National Night Out and said there were nine events in Ward Three and the weather was great.

Councilmember Quinn thanked the participants of National Night Out and Chief Humphrey and the Police Department, who did a great job in organizing this event. He said it was a good time to spend with constituents.

Councilmember Williams said he made seven out of nine events in Ward 2 because "The Talk of the Town" orchestra was at Rivermont Retirement Community and he stayed and listened to the music. He commended the Police Department because this was a fine way to remember and see firsthand some of the things that make Norman special.

Councilmembers Miller and Heiple agreed that National Night Out was a great event.

Mayor Rosenthal apologized to all of the people at the event she was not able to attend because it is hard to make so many events that are spread all over town. She said she appreciated her police escort who did a great job getting her to as many places as she was able to go. She said there was every kind of event, those with many small children, those who were older neighborhoods, and the Crime Free Multi-Housing Units. What is important is the relationships they build with one another.

Miscellaneous Discussion, continued:

Red River Rivalry. Councilmember Castleberry thanked the Mayor for allowing Councilmember Holman and himself to present the City of Norman Proclamation at the City of Dallas reception celebrating a new ten year contract for the Red River Rivalry in Dallas. He said it was a nice event and Councilmember Holman did a fantastic job reading the proclamation. He said fortunately the City of Norman won the bet so the Mayor does not have to give up those valuable tickets to the Norman Music Festival.

Mayor Rosenthal said she appreciated Councilmembers Castleberry and Holman representing Norman in Dallas.

Thanks to Public Works. Councilmember Castleberry thanked the Public Works Department for fixing some problems areas and he wanted people to know that City Staff is fantastic, but they can only fix problems they know about. He said if there is a problem, call your Councilmember and they will turn in

the complaint.

Domestic Violence Awareness Proclamation. Councilmember Miller said she was glad there had been a proclamation this evening about Domestic Violence Awareness but it is terribly sad that there were 1,100 people that went through the Women's Shelter last year. She said Norman is very lucky to have the Women's Shelter and many other agencies that help women and children in these situations. She said people watch this happening on TV and in other countries, it needs to be understood that it is a critical issue in our country and something should be done about it because it is wrong.

Fall Cleanup and Household Hazardous Event. Mr. Steve Lewis, City Manager, said Fall Cleanup is happening at this time. He said a couple of neighborhoods who have Monday and Tuesday service have already been picked up and the cleanup efforts will continue on October 18th with Wednesday service; October 25th for Thursday, and November 1st will be Friday service. He said the first weekend, 145 tons of materials was picked up. He asked that materials not be put out at the curb no more than one week before it is scheduled to be picked up. He said some citizens put debris at the curb several weeks before it is to be picked up causing numerous complaints. He said concrete, bricks, lumber, and other construction debris will not be picked up or junk cars. He said these items can be disposed of at the Household Hazardous Waste Event, which will be Saturday, November 1st at the Lloyd Noble Center from 9:00 a.m. to 2:00 p.m. He said this is an opportunity for residents to dispose of chemicals, pharmaceuticals, pesticides, fertilizers, motor oil, and old appliances.

Mayor Rosenthal said that this Saturday is also OU Homecoming and asked citizens residing in the core area to get their items out early so it can be picked up early to allow Norman to look good.

Mayor Rosenthal also encouraged citizens to take advantage of the Household Hazardous Waste Event and keep all this unwanted debris out of the landfill.

Bike Paths. Mayor Rosenthal said she had recently been in Eugene, Oregon and has brought back many pictures of bike paths. She is confident this will work in the Center City Vision area.
