A strip of land lying in Block 6 of Lydick's First Addition to the City of Norman, Cleveland County, Oklahoma according to the plat recorded in Book 3 of Plats, Page 21 being more particularly described as follows:

Commencing at the southeast corner of Lot 1, in Block 1 of Security Addition according to the plat recorded in Book 18 of Plats, Page 157;
 Thence North 89°44'57" East, along the south line of Block 6 in Lydick's First Addition, a distance of 166.05 feet to the Point Of Beginning;
 Thence North 00°15'06" West a distance of 5.00 feet;
 Thence North 89°44'57" East, parallel with the south line of Block 6 in said Lydick's First Addition, a distance of 55.68 feet;
 Thence South 00°00'00" East a distance of 5.00 feet to a point on the south line of Block 6 in said Lydick's First Addition;
 Thence South 89°44'57" West, along the south line of said Block 6, a distance of 55.66 feet to the Point Of Beginning.




