She said there will be food trucks, dancing and fun family time.

Storm Water Steering Committee. Mayor Miller said a Storm Water Citizen Steering Committee was appointed this evening and she wants to publicly thank the sixteen citizens of our community that were willing to serve on this committee. She said this is the most critical decision that Council will make this year and possibly next year on whether or not the City will be able to implement a Storm Water Utility in our community. She said this has been a topic of discussion for years. The Stormwater Master Plan completed in 2009 recommended a Storm Water Utility and the City of Norman falls farther and farther behind every single year in being able to maintain our storm water system and prevent the kinds of problems that exist. She said the City desperately needs a utility to fund improvements and new infrastructure, to repair the stream health, to make a difference about the water quality, and to stop the flooding. She said the Citizens' committee is being asked to come together and spend some time with our consultant. There has been a lot of preparation for their first meeting which is still being finalized. She said Council was very careful in selection of the committee, which represents different constituencies such as a Homeowner's Association, rural areas, small business, large business, professional expertise, etc.

CITY MANAGER'S REPORT

Plan Norman Open House. A PlanNorman Open House is scheduled for May 11th from 4:00 p.m. to 6:00 p.m. in the City Council Chambers. There will be two presentations (4:30 and 5:30 p.m.) with information about the different growth scenarios and opportunities for the public to submit comment cards. For those who cannot attend, the 5:30 p.m. presentation will be aired live on Norman Life TV on Cox Channel 20 and AT&T U-Verse Channel 99. It will also stream live on the City's website.

<u>Oklahoma Department of Transportation Meeting</u>. The Oklahoma Department of Transportation is hosting a meeting for residents to voice concerns and recommend solutions for addressing congestion on the I-35 Corridor. The portion of I-35 that will be studied stretches from just north of North 5th Street in Moore to just north of Main Street in Norman.

The section of I-35 at South 19th Street in Moore is one of the busiest in the state based on a 2015 traffic study that counted 120,000 vehicles a day. There are changes that can be made to intersections, ramps and service roads to improve traffic flow.

The City of Moore has plans to construct a new S.W. 34th Street bridge over I-35 in the current Federal Fiscal Year and Oklahoma Department of Transportation plans to go out to bid in Federal Fiscal Year 2022 to replace the Indian Hills Road Bridge over I-35.

The meeting is Thursday from 4:00 p.m. to 7:00 p.m. at The Station in Moore, 700 S. Broadway. It is an Open House format so those who attend can come and go at their convenience.
